1. REVIEW AND APPROVE MEETING AGENDA

3. INTRODUCTIONS AND PROGRAM UPDATES

Meeting attendees shared updates on their programs, some highlights follow:

- Ryan Collins announced that the City of Davis is moving forward with a contract with CommuniCare to provide an onsite nurse during the Interfaith Rotating Winter Shelter in Davis for the 2018-2019 season. He explained that the City of Davis was training first responders to utilize a Winter Shelter App that shows bed availability live and during after-hours.
- Rachel Nervo from the VA announced that the VA was receiving 5 more HUD VASH vouchers for Yolo County.
- Erin McEwen and Amber Whitaker both spoke about the Winter Warming Center proposed by the Mercy Coalition in West Sacramento during the 2018-2019 winter season. Amber explained that the project was going before the City of West Sacramento City Council on November 7th. Martha Teeter asked if community support was needed, and HPAC was invited to attend to show support.

4. ELECTIONS

Kim Heuvelhorst explained how the Nominating Subcommittee received nominations through October 5, 2018. As of that time, two individuals were nominated for HPAC Chair, with the Vice-Chair and Secretary positions receiving one nomination each. HPAC made a final decision regarding the Chair position through a vote of HPAC voting member agencies via a SurveyMonkey poll between October 10 – October 18, 2018. Ryan Collins received the highest number of votes in that poll. As such, the Nominating Subcommittee recommended the following slate of officers for 2019.

5. BRINGING FAMILIES HOME (BFH) DATA SHARING

Emily Meza led a discussion regarding the Bringing Families Home (BFH) program and a data sharing request from the State of California. On October 17th, the Data Subcommittee met and discussed the Data Use and Transfer Agreement that the State of California requested Yolo County agree to, in conjunction with the Bringing Families Home grant. The program assists families involved in the Child Welfare System to stabilize and reunite when lack of housing is the primary barrier to family reunification. Ryan Collins shared the Data Subcommittee's recommendation that Yolo County participate in the data sharing request. He explained how the Data Subcommittee heard from the lead researcher with whom the State of California is working to perform evaluation of the program. The lead researcher had explained that the data taken from HMIS would be ran through a system, "cleaned", and the report received by the researchers would be coded and de-identified information. The Data

Subcommittee determined that the security measures in place to protect client information were adequate.

Discussion of the merits of participating in the agreement followed:

- Amanda Ekman provided background about the Bringing Families Home program being a pilot program that Yolo County was participating in and that the HMIS data requested by the State of California was needed to inform a larger evaluation of the program's effectiveness statewide. The evaluation is important because it can affect whether the BFH program as a whole continues to be funded. She explained that without the full scope of data requested, the evaluation would lack a control group to compare BFH participant outcomes against.
- Bill Pride asked whether sharing HMIS data of this kind was covered in the release of
 information that clients sign before their information is entered into HMIS. Emily Meza
 confirmed that both the HMIS release of information and HMIS privacy statement specifically
 state that client information may be shared for research purposes in compliance with all
 applicable federal and state regulations governing the sharing of client identifying information.
- Jeneba Lahai asked how many families had been served through the BFH program in Yolo County. Amanda Ekman stated that 20-25 families had been housed through the program.

The following motion was then made and passed unanimously:

1. The Yolo County CoC agrees to share the requested HMIS data with the State of California as stipulated in the Data Transfer and Use Agreement, and that the entity deemed appropriate by a legal review (ie: County of Yolo, HPAC Chair, etc) would sign the document.

6. CALIFORNIA EMERGENCY SOLUTIONS AND HOUSING (CESH) & HOMELESS EMERGENCY AID PROGRAM (HEAP) UPDATE

Emily Meza informed the group that the CESH application was submitted timely before the October 15, 2018 deadline. She explained that notices of 8 notices of intent were received for CESH and 7 were received for HEAP. HEAP applications were due by the end of the day (October 24), and CESH applications were due by October 31. Bill Pride expressed concern that an agency that does not participate in HPAC was applying. Tracey Dickinson explained that many sources of funding, including CESH and HEAP, require an open and public project selection process, so HPAC could not restrict applicants to only HPAC members. Also, Tracey explained that HPAC participation would be written into contracts as a requirement, once funds were awarded.

8. 2019 POINT-IN-TIME (PIT) COUNT PLANNING

Emily Meza explained the importance of the annual Point-in-Time (PIT) Count, explaining that the U.S. Department of Housing and Urban Development (HUD) requires each local Continuum of Care (CoC) to plan and conduct a PIT count of homeless persons within their designated service area. HUD relies on PIT data to define the nature and extent of homelessness as well as to measure progress towards ending homelessness. Also, that the count must take place within the last 10 days of January and that it must include both the sheltered and unsheltered homeless population at least every two years. In 2018, only the sheltered count was completed, so in 2019, Yolo County must also conduct the unsheltered count.

A discussion of the 2017 efforts followed. It was explained by city representatives that during the count, individuals living in areas on County property would be included in the city's geographic region count. There were varying opinions on utilizing volunteers during the count and a strong desire for volunteers to be informed about best practices when working with individuals living homeless. It was expressed that the general methodology used in 2017 was appropriate and could be followed again in 2019.

9. NO PLACE LIKE HOME (NPLH) COUNTY HOMELESS PLAN

Sandra Sigrist explained the importance of the County completing a Community Input process to formulate a County Homeless Plan that meets very specific requirements of the No Place Like Home program. The County intends to submit an application by the January 15, 2019 deadline, so the input process must be completed by the end of December 2018. There would be a Community Input Launch day on November 13, 2018 and smaller summits in each of the three major cities, the first week of December.

10. LONGITUDINAL SYSTEMS ANALYSIS (LSA) REPORT

Emily Meza explained the purpose of the LSA. She explained that it is the data report submitted to HUD that informs the Annual Homeless Assessment Report (AHAR) provided to congress each year. The AHAR is utilized by lawmakers during policy development. Emily explained that the 2018 LSA was modified to provide a more thorough view of homelessness than in previous years. Not only would it provide more data points, it also included more housing project types than it previously did. An initial test upload is due in the HUD system by November 9, 2018, and the final report is due by November 30, 2018.

11. 2019 MEETING SCHEDULE

Kim Heuvelhorst presented the draft 2019 HPAC Meeting schedule and solicited feedback from HPAC about where to hold the meetings in Davis and West Sacramento. HPAC agreed that the Davis Police Department Community Room was most appropriate due to the Davis Library being unavailable on the dates needed. Also, Amber Whitaker from the City of West Sacramento offered to find meeting space and would follow up with Kim with more information.

AVAILABLE FUNDING

The Project Selection Subcommittee was tasked with making funding recommendations for two different grants: the Homeless Emergency Aid Program (HEAP), and the California Emergency Solutions Grant (CESH). The total funds available to allocate to individual projects is the total grant allocation minus a five percent administrative cost.

Available funding for each grant is described in the chart below:

SCORING AND FUNDING RECOMMENDATION PROCESS

Subcommittee members received the application packets on Friday, November 2, 2018, and had thirteen (13) days to individually score each project on a 90-point scale. The Subcommittee met as a group on Thursday, November 15, 2018.

First, the Subcommittee reviewed the scores and discussed the merits of each project individually, and then developed aggregate scores for each project. Then, the Subcommittee made the following final funding recommendations.

NOTES ON FUNDING RECOMMENDATIONS

The Subcommittee evaluated the projects for funding based on a variety of factors, including: score, whether an agency applied for the same activity under both grants, whether similar activities were proposed by more than one agency, and community need.

• The HEAP funding recommendations were based on prioritizing the highest amount of funds for the Fourth & Hope application as the proposed activity would meet a huge community need for more emergency shelter beds. However, the Subcommittee was hesitant to fully fund the Fourth & Hope application as it would account for the total allocation available to Yolo County and the project was in the beginning stages of development. The Subcommittee determined it was best to fund as many projects as possible with the HEAP funding while still prioritizing

emergency shelter beds. As such, all of the other HEAP applications were partially funded except Resources for Independent Living and the Interfaith Rotating Winter Shelter of Davis.

- The CESH funding recommendations reflect the Subcommittee's decision to fully fund all
 projects except the lowest scoring (Resources for Independent Living) and the City of Davis
 application. The funding recommendation for City of Davis is slightly less than requested due to
 a duplication of services funded under the City of Woodland application and concerns that
 oversight of the flexible fund spending was not as robust.
- Resources for Independent Living (RIL) scored the lowest in each grant and therefore, only one
 project was recommended for funding (HEAP Youth Transition Services Program) as it was the
 only project that specifically serves the youth population, one of the target populations of the
 HEAP grant.
- Both the HEAP and CESH applications from the Interfaith Rotating Winter Shelter of Davis (IRWS) were recommended to be fully funded due to the nominal amounts applied for in comparison to other projects and a better than average score under each grant.
- For Empower Yolo, only the CESH application was recommended for full funding as both applications were for the same proposed activities. The Subcommittee determined the partial funding amount for the HEAP grant by subtracting Empower Yolo's total CESH funding recommendation from the amount requested under HEAP.
- For the Yolo County Children's Alliance (YCCA), only the CESH application was recommended for full funding as both applications were for the same proposed activities. The Subcommittee determined the partial funding amount for the HEAP grant by subtracting YCCA's total CESH funding recommendation from the amount requested under HEAP.
- The City of Davis application for HEAP was recommended for partial funding at the amount described in their application for funding project activities at Level 1.
- The City of Woodland application for CESH was recommended at full funding as it was the only application submitted by the City of Woodland.
- The Davis Community Meals and Housing application for HEAP funding was recommended for partial funding, reduced by 1 year of housing subsidies to be provided by the program.

YOLO COUNTY CONTINUUM OF CARE

PROJECT PROPOSAL FROM HOMEBASE

TECHNICAL ASSISTANCE VISITS TO SUPPORT COC- AND ESG-FUNDED AGENCIES

HomeBase/The Center for Common Concerns (State and Local Programs) is a California-based, nonprofit agency providing public policy-oriented technical services to assist communities in developing effective responses to homelessness and poverty. With more than 30 years of experience on the issue of homelessness, HomeBase is a recognized national leader with extensive expertise and experience on this topic, including deep understanding of the root causes of homelessness and wide-ranging knowledge of best practice solutions.

The Yolo County Continuum of Care annually applies for funding from the U.S. Department of Housing and Urban Development (HUD) Continuum of Care (CoC) Program. Yolo County providers also apply for and receive California Department of Housing and Community Development (HCD) Emergency Solutions Grant (ESG) program funding. The CoC is required to monitor compliance and performance of all CoC- and ESG-funded projects annually, as well as assess program performance and effectiveness.¹

This proposal outlines a series of one-on-one, on-site programmatic technical assistance visits by HomeBase to all CoC- and ESG-funded agencies in Yolo County. It will include, where applicable, review of subrecipients.

PROPOSED SCOPE OF WORK

The agencies and projects that receive technical assistance will include up to ten CoC and/or ESG-funded recipients and subrecipients as identified by the Yolo County Forensic and Homeless Programs Manager.

The primary goals of technical assistance visits are to:

- 1. Fulfill the requirement of the CoC to monitor CoC- and ESG-funded recipients and subrecipients;
- 2. Improve program performance, effectiveness and efficiency;
- 3. Increase knowledge and capacity among CoC- and ESG-funded agency and contract staff regarding best practices and program requirements;
- 4. Help agencies prepare for HUD monitoring by reviewing agency documents and client files for compliance, and assist agencies in remedying any issues;
- 5. Identify opportunities and gaps for additional trainings or one-on-one meetings regarding these topics.

Planning/Preparation for Each Project

HomeBase and the Yolo County Forensic and Homeless Programs Manager will work together to identify 2-3 areas of focus for the technical assistance visits (e.g., opportunities to improve each project's individual contributions to system-level performance measures, opportunities to improve fidelity to the Housing First model, opportunities to strengthen partnerships through the coordinated entry system).

To prepare for the technical assistance visits, HomeBase will review and analyze background documents, performance reports, and like documents for to identify opportunities to apply best practices, improve performance, and ensure program compliance. Agencies will be asked to provide HomeBase with documents from their ESG- and CoC-funded programs leading up to the meetings, which may include:

- Agency policies and procedures;
- Performance reports;
- HUD monitoring reports and agency responses associated with the ESG- and CoC-funded projects since January 2016; and
- Grant agreements or contracts with HUD, HCD, or the CoC plus subrecipient contracts.

On-Site Visit

HomeBase will conduct on-site programmatic technical assistance visits to identify areas for improving program effectiveness and efficiency and assess compliance with program requirements. The length of the TA visits will be determined by number of CoC- or ESG-funded projects the agency has, but most will last about an hour. The visits will include discussions with agency staff about programs and concerns and a review of each project's materials and files (which may include client files) and ideas for how to meet agency goals and improve project performance.

Follow-up Plans for Agencies and CoC

At the conclusion of the technical assistance visits, HomeBase will draft a follow-up plan for each project that identifies key areas for action and describes any next steps that should be taken or improvements that could be made. HomeBase will provide copies to the Yolo County Forensic and Homeless Programs Manager to ensure follow-up action.

DELIVERABLES/TIMELINE

HomeBase will conduct a planning call with the Yolo County Forensic and Homeless Programs Manager and other CoC representatives, as relevant, in February 2019, with technical assistance visits to take place before June 30, 2019.

ESTIMATED BUDGET
