Yolo County Criminal Justice Grant Writing Team

CCP Update – 1/7/19

1. Submitted Applications

a. CalOES Transitional Housing (XH): ACCEPTED

In partnership with Fourth and Hope. \$300,000 annually; successful applicants are able to re-apply non-competitively for up to four subsequent years. Goal is to fund a new 10-unit apartment complex to serve as transitional housing with full case management services. Empower Yolo would provide rapid re-housing services.

2. Upcoming Grants

a. BSCC Justice Assistance Grant (JAG)

RFP released. Applications due April 25th, 2019. Notice of intent has been submitted by the District Attorney's Office. This grant currently funds the Neighborhood Court restorative justice diversion program. Funding expected to begin in October 2019.

b. BSCC Prop 47 Funding: Round Two

Anticipated RFP release in January 2019. Awards expected to be made in August 2019. \$1M available for small scope projects, up to \$6M available for large scope projects. Funding could be used to sustain the existing Extended Hope program, which is currently funded by a federal SAMHSA grant, or to expand the forensic team.

c. BSCC Adult Reentry Grant (ARG)

Anticipated RFP release in early 2019. This grant gives us a second opportunity to fund reentry programming after the unsuccessful federal application. Would follow same model: an Adult Reentry Coordinator position with a team of Case Managers.

d. BSCC Youth Reinvestment Grant (YRG)

Anticipated RFP release in early 2019. This grant is focused on providing diversion opportunities for low-level juvenile offenders. Could potentially fund the Evening Learning Center project as the centerpiece of a diversion program, as well as a Social Worker for the Public Defender's juvenile conflict cases.

e. DSH Incompetent to Stand Trial Diversion Grant (IST)

Competitive funding solicitation from Department of State Hospitals to fund the mandated AB 1810 mental health diversion programming. Grant will require a 20% match. One-time funding, so there would need to be a

plan in place to sustain staffing after three years. RFP was released on 12/31/18. Potential funding is based on service targets, with the goal of reducing DSH referrals by 20% - 30%. In FY 16-17 Yolo County sent 38 felony defendants to DSH for treatment. Projected potential funding is between \$1,079,200 and \$1,618,800 based on how many individuals the new program proposes to serve annually, for a period of three years.

f. OJP Justice and Mental Health Collaboration (JMHC)

Anticipated RFP release in January, February, or March. Peer feedback from the proposal evaluators on our last proposal indicated that we were actually fairly close to receiving federal funding. Planning to re-submit with modifications to address the evaluator's concerns and take another shot at securing funding for Mental Health Court. Would fund an additional Clinician and Probation Officer to work for the program and double capacity from 15 clients to 30 clients.

g. BJA Adult Drug Court Discretional Grant Program (ADC)

Anticipated RFP release in January, February, or March. Grant would provide an opportunity to expand the Addiction Intervention Court's staffing and capacity, likely following the same staffing model as the JMHC proposal.

h. OJP Second Chance Act – Adult Reentry Program (SCA)

Anticipated RFP release in January, February, or March. In partnership with CommuniCare, would have funded an Adult Reentry Coordinator position and three Patient Navigator positions to provide assistance for individuals released from county jail or state prison to successfully reintegrate into Yolo County's communities. Peer feedback from the proposal evaluators on our last proposal indicated that we were actually fairly close to receiving federal funding.
