Health Education

- The Yolo County Nutrition Education Obesity Prevention program (NEOP) and the Oral Health program are partnering to support the development of the Champion Provider Fellow for Yolo County. Dr. Barry Chang, DDS, at CommuniCare Health Centers will participate in the Champion Provider Fellowship training facilitated by UCSF in Spring 2019. Once completed, the Champion Provider Fellow can serve as an advocate and spokesperson for advancing policy, system, and environmental change initiatives that reduce obesity risks and oral Health programs in Yolo County. Rebecca Tryon, Program Coordinator for both NEOP and Oral Health, will be the liaison between the NEOP and Oral Health program initiatives and the Champion Provider Fellow activities.
- Since June 2018, HHSA’s Community Health Prevention Staff have been facilitating a community collaborative in Knights Landing to increase services and opportunities available to youth in Knights Landing. The mission of this collaborative is “to catalyze rural youth development through positive relationships and community resources to empower individual growth. Talents and ideas.” Since the start of this Knights Landing Youth Development Collaborative (KLYDC), it has seen several successes in the Knights Landing community. These successes include:
 - Creation of the KLYDC and the development of the KLYDC mission statement.
 - Mental Health counseling services provided to Sci-Tech Charter school through RISE Inc.
 - Friday Night Live teaching 2 cycles of 10 weeks of Alcohol, Tobacco & other Drug Education to 5th & 6th graders during the school day.
 - Yolo County Library – Knights Landing branch has active programs for youth and families during library hours.
 - More community members are coming to the Knights Landing library and accessing services and participating in library programming.
 - This collaborative has increased its partnerships to bring together resources and services for youth and families.
 - Knights Landing Family Resource Center has active youth programs.
 - Community is gaining trust in the KLYDC.

Community Health Report January 2019

- There has been no tagging, vandalism or breaking of windows at the Family Resource Center since the KLYDC started meeting.
- There has been more noticeable community engagement and pride.

Members of the KLYDC collaborative represent the following agencies: Yolo County Administration, Yolo County Health & Human Services, Cache Creek High School, Yolo County Office of Education, Knights Landing One Health Clinic, RISE, Inc., Sci-Tech Charter School, Knights Landing Family Resource Center, Yolo County Library – Knights Landing Branch, Supervisor Duane Chamberlain’s office, Knights Landing Youth, Empower Yolo, and UCD Knights Landing Environmental Health Project.

- In October 2018, Winters High School Friday Night Live (FNL) competed with other Northern California high schools in a Teen-To-Teen Safe Driving Campaign sponsored by All State Foundation and Safety Center. The goal was for high school students to promote teen safe driving in creative way and possibly win money for their school or club! This year Winters High School placed third and won \$500 for their FNL club. FNL members created a PowerPoint presentation with short video clips about Red Ribbon Week and distracted driving information and statistics. All students saw this presentation in their advisory class. This presentation was then followed up with a lunchtime resource fair where students could get safe driving information from local law enforcement, firefighters, Allstate Insurance, Safety Center and Yolo County Friday Night Live. FNL members also set-up an obstacle course where students could drive a pedal cart wearing the fatal vision goggles, which simulated being under the influence of alcohol.

From September through November 2018, Yolo County Friday Night Live Youth Council (YCFNLYC) members collected new bottles of lotion and new socks. Their collection was donated to a local church in Yolo County. The socks and lotion were included in a kit that would be donated homeless individuals in Yolo County.

Maternal, Child, Adolescent Health (MCAH)

- The [Yolo County Maternal Mental Health Collaborative](#) continues to meet monthly to share resources, provide updates on emerging maternal mental health efforts, and work through case studies to increase collaboration and identify assets and gaps in Yolo County. Strengthening collaboration and building resources to support providers and mothers are the focus of this effort. These resources are vetted by collaborative members and organized by protective factors. The collaborative is open to anyone interested and no RSVP is required. - Yolo County Healthy Schools Collaborative, a partnership between public health and school districts held its Fall 2018 meeting on November 28, 2018 at the Yolo County HHSA offices from

3:30-5:00pm. Updates from multiple branches in Yolo County HHS including Immunizations, CalWORKs, CalFresh, Housing and Child Welfare were provided to attendees. The collaborative was first born almost 20 years ago as the Public Health Nursing – School Nurses Countywide Meeting. Two years ago, it was revamped to include other disciplines from the school district and Yolo County including, but not limited to behavioral health, social work and child welfare. The Collaborative holds two meetings a year and is by invite only for the purposes of strengthening collaboration between HHS and schools to meet mandates such as vaccinations, child abuse and neglect reporting and access to social services. - Fetal and Infant Mortality Review (FIMR) will hold its quarterly meeting on January 10, 2019 from 11:30-2:00pm in the Clarksburg Room of the Gonzales Building. - Sudden Infant Death Syndrome (SIDS) Prevention, The Yolo County Safe Sleep Education Module is almost complete. It is a 10 minutes interactive education module in English and Spanish, that focuses on the ABC's of Safe Sleep (**A**lone, on their **B**ack, and in a **C**rib). We hope to collaborate with other county agencies who work with high risk parents that are either pregnant or have babies under the age of one who cannot afford to provide a safe sleep environment for their baby. Once the parent/caregiver takes this free online module, they can print out a certificate and present it to MCAH SIDS Coordinator for a free cribette. We are currently seeking a funding source to purchase these cribettes from our partners at Cribs for Kids. This module was a collaboration between MCAH and the Department of Media Arts, Design and Technology, CSU Chico State.
- Comprehensive Perinatal Services Program (CPSP), Our Spring Roundtable will be in May 2019. The focus will be on the topic of Grief and Loss. More details to follow soon.

Infectious Disease/Communicable Disease

- Effective January 1, 2019 the Yolo County Safety Net Clinic has changed hours to 2:00-5:00pm in order to help accommodate working families. Patients are now asked to contact the clinic before arriving at (530) 666-8552 to schedule an appointment. Appointments will allow the nurses to prepare ahead of time, and more efficiently process patients with complicated vaccination needs.
