#### **RECOMMENDED ACTION:**

A) Authorize the continuing resolution to allow for payment of YCH obligations in FY 2008-2009 pending approval of the final budget for FY 2008-2009...

#### **BACKGROUND/DISCUSSION:**

Adoption of a continuing resolution allows YCH to pay its continuing obligations allowed in the fiscal year until the final budget for FY 2008-2009 is adopted.

It is anticipated that the proposed budget for FY 2008-2009 will be brought to this Board for consideration in the month of August 2008..

#### **FISCAL IMPACT:**

Expenditure of funds will be higher than 2007-2008 funding, but within revenue projections.

#### **CONCLUSION:**

The continuing resolution allows the YCH to meet its financial obligations, i.e. payroll, vendor payments, Section 8 payments to landlords.
