4. PUBLIC COMMENT

• Shantille Connolly gave an overview of the "Helmet Hair, Don't Care" campaign through the Student Health Services at UC Davis.

5. STATE AND COUNTY UPDATE - Jill Cook, County Administrator's Office

- Homeless Funding: The passing of Proposition 2, which authorizes the state to use revenue from the Mental Health Services Act (MHSA), is now available to counties to use for homelessness prevention housing, for people in need with mental health services.
- Adult Day Health Center: A consulting architect is currently exploring three options:
 - Renovation and expansion of the current site
 - Purchasing an existing two-story office building, with the first-story converted to Adult Day Health
 - Building a large new facility that would also house many Health and Human Services Agency programs and other similar programs

The goal is to look at cost and timeline, and present the information to the Board Ad-Hoc subcommittee along with Dignity to commit to a path in hopes to have a decision made in January 2019.

• **Board of Supervisors:** The Board has two meetings left in 2018, and then the Chair switches over. In 2019, the Chair for the Board of Supervisors will be Supervisor Don Saylor; and a new Board member, Gary Sandy, will be replacing Matt Rexroad for District 3.

In 2019, it will be a year of strategic planning for the Board to prepare for the next five-year Strategic Plan that will start in 2020. The Board is currently working on the Community Engagement Plan that will include rolls for this advisory board as well as other advisory boards.

- Smoke Free County Property Ordinance: Starting January 1, 2019, all Yolo County campuses, owned or leased, will be smoke free.
- 6. BOARD OF SUPERVISORS UPDATE Jessica Jones, Assistant Deputy to Supervisor Saylor
 - Local Mental Health Board's Annual Report: On October 23rd, the Local Mental Health Board (LMHB) presented the Board of Supervisors their Annual Report, which included the Board's accomplishments over the last year and their goals for the future. LMBH has focused on expanding access and services to our rural communities; as well as exploring a name change to the Mental and Behavioral Health Board.
 - Juvenile Hall: On November 6, 2018, the Board of Supervisors recognized the Bill Rickers' family at the building dedication ceremony naming the Juvenile Detention facility gymnasium after Bill Rickers, who was a teacher at Juvenile Hall.
 - Interfaith Winter Shelter: On November 6, 2018, the Board of Supervisors approved funding for the interfaith winter shelters for the cities of Woodland, West Sacramento, and Davis.
 - Save the Date: December 13, 2018, will be the naming ceremony for the Davis offices at 600 A Street. The building will be named after Helen MacLeod Thomson the Health and Human Services Agency Service Center and District Offices.
 - **Soup's On:** Supervisor Saylor's Annual Soup's On will be held on January 24, 2019, from 6:00-8:00pm; at the St. James Church, 1275 B Street, Davis; and this year we will be recognizing the Putah Creek Council. Additional information, or to register, go to: <u>www.donsaylor.org/soups-on</u>.

7. COMMUNITY HEALTH BRANCH REPORT – Brian Vaughn, Public Health Director Branch Report

• Emergency Medical Services (EMS): Partnered with local fire departments and law enforcement agencies to conduct a series of emergency training and active shooter exercise at the Historical Court House in Woodland. It was the first time all law enforcement, fire, EMS personnel and the County's Emergency Preparedness team came together for a drill, giving first responders an opportunity to train in real-live situations in real-time. The training and exercise was very successful, and the lessons learned from the exercise has positively impacted how Yolo County responds to an active shooter event.

This week we are currently in a week long statewide health emergency drill. Today we will be having a scenario of an anthrax release, setting up a medical distribution pod, and running through a practice to mass medicate employees.

• Friday Night Live (FNL): FNL students from River City and Winters High Schools participated in a statewide Roadwatch. Students observed busy intersections, from 7:00am to 8:00am, watching for distracted drivers. Students found more than one in ten drivers were distracted, whether it was eating, drinking, reaching for something or on their phones.

8. HEALTH OFFICER REPORT – Ron Chapman, Health Officer

• **Syphilis:** Usually the county has one or two pregnant women with syphilis a year; but this year it is up to seven cases. The overall number of syphilis cases continues to grow. We had a productive call with the California Department of Public Health; and they will be helping us figure out a strategic approach to this issue. In December a meeting will convene of people across county government, and a handful of external partners, to begin discussions on how we can approach syphilis across the county.
