**4. PUBLIC COMMENT**

**5. STATE AND COUNTY UPDATE – Jill Cook, County Administrator’s Office**

- **State Budget:** The Governor’s budget is expanding Medi-Cal for undocumented adults ages 18-26. The proposal is to fund this expansion by directing additional Health Realignment funds from counties. This is a proposed revised of AB85 (2015).
- **County Budget:** FY 2019-2020 County Budget preparation has begun. All departments are in budget planning mode. The County Board of Supervisors will hold a budget workshop on February 19, which will allow each Department to share accomplishments to date, future goals and priorities as well as any emerging issues.

**6. BOARD OF SUPERVISORS UPDATE – Tara Thronson, Assistant Deputy to Supervisor Saylor, District 2**

- **Office of Refugee Resettlement (ORR):** At the January 29, 2019 Board meeting, the Board of Supervisors voted to approve the budget grant cycle from February 1, 2019 to January 31, 2020, to maintain the ORR program in Yolo County.

Since the last update to the Board in April 2018, staff negotiated with ORR to receive grant funding to hire additional staff. It is anticipated that additional staff will increase the availability of supportive counseling for youth.

- **Health Council’s Annual Report:** At the February 5<sup>th</sup> Board meeting, Dr. Wilkes presented the Health Council’s Annual Report, which was well received by all Board members.

- **Soups On:** Thank you to all those who supported or attended Supervisor Saylor’s 15<sup>th</sup> Soups On event to support Putah Creek Council. Collectively we raised about \$44,000 to help with educational programming.

**7. COMMUNITY HEALTH BRANCH REPORT – Brian Vaughn, Public Health Director**

- **Women, Infants, and Children (WIC):** The Breastfeeding Coalition won an award for their coalitions’ support of the Surgeon General’s “Call to Action to Support Breastfeeding”.
- **Tobacco Prevention:** The tobacco team is starting conversations with Davis and West Sacramento City Council members to propose a policy ban on the sale of tobacco in those communities.
- **Maternal, Child, Adolescent Health (MCAH):** The MCAH Needs Assessment show that up to 1 in 5 women have symptoms of postpartum depression. Rates of pregnant women hospitalized for mental health issues are on the rise, and greater than the state average rate.

**8. HEALTH OFFICER REPORT – Ron Chapman, Health Officer**

- **SB1152:** Effective January 1, 2019, California has a new law for hospitals discharging a patient who is experiencing homelessness, to screen the patients for HIV, Hepatitis C, Syphilis, Gonorrhea and Chlamydia; and according to the Centers for Disease Control (CDC), immunize patients for Hepatitis A, Tdap and Influenza.

**9. MARCH MEETING – Brian Vaughn, Public Health Director**

- At the January 10, 2019 Health Council meeting, there was a discussion to have the March 14<sup>th</sup> meeting relocated at the Juvenile Hall facility, and then tour the Office of Refugee Resettlement (ORR). After consideration, the March meeting will stay at the Health and Human Services Agency; and Cyndi will send out an email asking members if they would like to participate in touring the ORR facility at a later date.
