Member Updates-

Yolo County – Marissa Juhler

- Tire Amnesty Event at the Esparto Transfer Station – April 10, 2019 and Woodland on April 27, 2019 – at the Yolo County Central Landfill.
- Thrift Store hours of operation will be changing. From 6 times a year to 9 times a year. These dates are listed on our 2019 calendar.
- Homeless camp cleanup was completed along East street and County road 101A. This is funded out of the general fund.
- We're in the process of rewriting our franchise agreements.
- All of our annual Hazardous Waste reports applications were submitted on time.

Davis – Jennifer Gilbert

- Davis City Council has approved the Solid Waste Prop 218 notices—a proposed 5 year rate increase of 41.5% over the next 5 years. Council is also looking at changing the on-street yard material pile collection schedule. Possibly decreasing the number of pickups per year from 18 to 16, 15, or 12. There was some discussion of possibly eliminating this service all together at some point in the future, but Council did not want to decide upon that at this point.

- Woodland just signed a contract with DMV for used oil recycling ads on their monitors.
- Working with Waste Management to start the organics waste program's next round of requirements by January 1st 2019.

- We're moving forward with the Household hazardous Waste Grant (Cycle HD31). We'll be holding eight events.
