### Emergency Medical Services (EMS)

- The Yolo County Emergency Medical Services (EMS) Agency has been evaluating the effectiveness of our Exclusive Operating Area Contract for 9-1-1 Advanced Life Support and Critical Care Ambulance since the execution of the contract in March 2014. This contract was approved for a five-year period with a possible five-year extension based on performance. In November 2016, Yolo County Emergency Medical Services created the Emergency Medical Care Committee (EMCC) Subcommittee to discuss any concerns or needs with our stakeholders. Since the creating of the subcommittee, bi-monthly updates have been provided at the EMC meetings. Based on the feedback from the subcommittee and contractual compliance numbers, Yolo County Emergency Medical Services sent an offer letter to American Medical Response, the contracted provider, to extend the contract an additional five years. On February 26, 2019 the five-year extension was presented to the Board of Supervisors and approved.

### Women, Infants and Children (WIC)

- On March 8, 2019, the Breastfeeding Coalition held a Strategic Planning Meeting that was facilitated by Dr. Jane Heinig, Director of UC Davis Human Lactation Center.

### Communicable Disease

- The Immunization program has begun sending out educational material to schools regarding the updates to immunization requirements. Some of the highlights include:
  - Yolo County Safety New Clinic changed to appointment only effective January 1, 2019.
  - Immunization requirements have changed to try to create a more uniform vaccination coverage history throughout K-12. <https://www.shotsforschool.org/k-12/>
  - The Immunization program is providing on going education about family's Medi-Cal and CHDP rights in regards to receiving immunization and appointments at medical homes.

### Maternal, Child, Adolescent Health (MCAH)

- The Community Health branch is proud to work closely with the Yolo County Child Abuse Prevention Council and would like to take the opportunity to highlight that April is Child Abuse Prevention Month and share this message from our Council's coordinator, Natalie Audage:

In April, the Yolo County Child Abuse Prevention Council (CAPC) and Yolo County Children's Alliance (YCCA) will release *Nurturing Children During Times of Stress: A Guide to Help Children Bloom*. This resource for parents and caregivers, which will be launched during Child Abuse Prevention Month, contains tips and resources that parents and caregivers can use to promote resilience in their children and themselves. The guide explains the effects of intense stress or Adverse Childhood and Community Experiences (ACEs), focusing on prevention and emphasizing that healing is possible at any age.

The guide will be available in English, Spanish, and Russian in early April.
