3. Member Updates

Yolo County - Marissa Juhler

- Updates on the battery recycling program At our last meeting we discussed all battery recycling issues industry wide. There are a lot of fires occurring due to the mismanagement at the battery sites, primarily at recycling facilities and in transport. There was enough concern that we pushed the issue up to county counsel. The decision was made to remove some of the battery drop off sites. A blurb will be sent out to the Board of Supervisors with our suggestions.
- Battery drop off sites remaining West Sacramento; The Sacramento Battery Co., City Hall and Station 45. Davis; both CVS pharmacies, Hibbert Lumber Co., ACE Hardware, both Rite Aids, Senior Center, both Nuggets and the Food Co-Op. These locations will have county staff service the buckets every month. Woodland; Presbyterian Church, True Value, Nugget, City Hall, Corner Drug, Senior Center and OSH. These sites will be serviced every other month. Winters will be keeping all three of their locations and will be serviced as on-call.
- Yolo County will be removing the buckets at their county facilities. We will keep services in the rural areas; Yolo Library, Clarksburg Library and the Knights Landing Library.
- We will be utilizing our door to door pickup with Stericycle should anyone have an issue with the buckets being removed.
- Pharmaceutical updates Winters Police Department has their new kiosk in place. We're still waiting on a date for West Sacramento's kiosk. It should be in January.

West Sacramento - Paulina Benner

- West Sacramento wanted to end the battery drop off to those sites that we have the less amount of
 control over. For those sites that we're keeping for battery drop off, we will provide dedicated staff.
 This information will be advertised in the utility bills and the newsletter in December.
- West Sacramento food scrap program will be starting in January. Residents will be receiving the kitchen pails by request once the program starts.
- West Sacramento currently has an internship recruitment program going on. We're looking to add one possibly two interns that will focus on a door to door interaction to discuss AB1826 and AB341.

 certificate of destruction accompany it. Unless the material is dry it will not be sent to the green waste
 facility.
