5. COMMUNITY HEALTH BRANCH REPORT – MCAH HIGHLIGHTS – Anna Sutton

- **Cindy Martin:** Shared that they have had 19 people start training and are hopeful that they will make it through the entire training. Phone wait times are still long, please continue to encourage people to wait on the phone. Clients can access enrollment for MediCal and CalFresh online at if you go onto the HHSa website there are links for access these resources. There are 4 services center, recently opened one in Davis, there is one in West Sacramento, Winters, and Woodland. There is also a call center in Woodland but they do not do direct client contact. There have been no updates in regards to Public Charge.
- **Lizeth Betancourt:** Invited everyone to join the Breastfeeding Coalitions Strategic Plan on March 8th, 1:00-4:00PM. Lizeth will be sending out an invite. They will be developing long term and short term goals.
- **Brian Vaughn:** Shared that there is a piece of the new budget where each county will receive money from the state for budget realignment. There is a proposition to expand Medi-Cal to 19-25-year-old undocumented. There is a proposal to pull back realignment from the counties to the state. This will be a big hit for us. This is no categorical, and can be spread out throughout public health. Right now 5 counties are being targeted. Yolo County would be hit with \$1,00,000.

- We should make it more explicit that this is fact sheet on childbearing women and infants, so that's it's clear on what's missing and what is not

7. **0-5 ROOT CAUSE ANALYSIS** – Anna Sutton

- **Social and Community:** Unintended Pregnancy, Substance use, Mental Health, Social isolation (WHY), Safe and affordable respite
- **Education:** Parenting knowledge, Lack of safe/affordable preschool
- **Economic Stability:** Poverty(WHY?), Housing insecurity (generational), Familial obligations, Single parenthood
- **Neighborhoods and Environments:** Parenting knowledge, Safe and affordable respite care, Safety: violence, alcohol, drugs
- **Health and Healthcare:** Unintended pregnancy, Access to substance and mental health treatment, Untreated substance/mental health disorders, Lack of interpregnancy care
- **Consider Social Determinants:** Housing, Poverty, Environment
- **Parking Lot:** Planned/unplanned Pregnancy

- **Lupita Vital:** Shared that as of January 1st immunization clinic hours have changed. The new hours are 2:00-5:00 PM by appointment only. Families are encouraged to call a week in advanced to make an appointment. Right now they can only accommodate 6 people into appointment slots. It is still the first 4 Monday's in the month and these alternate between West Sacramento and Winters. They are trying to accommodate walk-ins for TDap and flu only but will depend on availability of Nurses. As of July 1st there are new immunization requirements for school age children.
