CALL TO ORDER

- 1. Welcome and Introductions: The February 25, 2019 meeting of the Local Mental Health Board was called to order at 7:00 PM. Introductions were made.
- 2. Public Comment: One group present with Pacifico inquires, and two other groups present with commentary and concerns regarding Pine Tree Gardens.
- **3. Approval of Agenda**: Brad motioned and approve, Richard asked for his additions regarding site visits and wants to chair the site visit ad-hoc subcommittee. Minutes approved with changes requested by Richard.
- 4. Member Announcements: James discussed the potential name change and mentioned that the outcome of the conversation with the Board of Supervisors was that the name will not change. If the name is something we want to change in the future, then we need to readdress that with a plan.
- 5. Correspondence: Linda Wight Re: Pacifico
 - a. Concerned about a fear response to the events at Pacifico. James reiterated that it's important that we take these issues seriously and wants us to continue looking at housing opportunities and our role in the community. James requested the LMHB's thoughts and opinions on the letter. Brad asked for clarification on the difference between Pine Tree Gardens and Pacifico. Karen stated that two of the four buildings at Pacifico have people living in them, but it's not being managed well so the community is questioning why more money would be spent there. Perhaps it's not the best option or use of money. Brad stated that it seems like Pacifico would be expensive to move somewhere else. Karen suggested that if the community continues to push back, then we'll look to other places for a residential treatment facility. John questioned the ratios of students and other residents in Pacifico. Supervisor Saylor clarified why Pacifico was called Pacifico and how the situation began

by targeting low income UC Davis students. The City of Davis is not currently managing the building, but Yolo County Housing is. It's currently operating as low income housing with many young people who many need services, but are not getting them on site. There are 2 vacant buildings on the property that are being discussed for the County project. The City thought a Planning Commission would best and in the course of that process it's brought to light the concerns of the neighborhood. The location is near a bike path which leads to lots of movement in the area and that's concerning for the neighborhood. Brad asked if the students are bothered by the "mobile population," as the neighbors are. Supervisor Saylor responded that he doesn't think that there are many students still living there. Davis City Council is considering options that may be different than what was originally proposed. It's a board and care facility that's proposed, and it's likely that the concerns expressed with the current situation would likely not be an issue with a managed residential facility. Nicki mentioned the model that Caesar Chavez has been working for the last 12 years and that doesn't seem to have any issues. Perhaps we should spend some time looking at that type of model? James said that Caesar Chavez is not in a single family home neighborhood. Sup Saylor said it's clear that many residents of Davis would benefit from the project should it be built. Lastly, this is a publicly owned facility that's not being used and the City has no way to do it alone. The County is trying to help utilize the property with public dollars and services.

Item 8. Mental Health Director's Report

Yolo County Local Mental Health Board Director's Report March 25, 2019

Pine Tree Gardens

Supervisors Provenza and Saylor met with the County Administrator and leadership from Turning Point and HHSA to review financial information and discuss a sustainable path forward for Pine Tree Gardens homes. We are meeting with the family/community members again on March 29th to discuss further.

Juvenile Detention Facility Mental Health Services

Karen is working with probation staff to transition mental health services from WellPath to Probation mental health staff in the new fiscal year. Additionally, we are bringing in an outside consultant to assist with re-vamping our Suicide Watch Protocol, training staff, etc. We are also updating all policies and procedures to be more trauma informed and evidence based.

Suicide Prevention Sustainability Planning

As a part of the ongoing effort to assist Suicide Prevention in becoming more sustainable, Karen Larsen, Diane Somers (Suicide Prevention and Crisis Services of Yolo County), County Administrator, Patrick Blacklock, and Supervisor Provenza met with the Superintendents from all local school districts and the Yolo County Office of Education to discuss ways we might partner toward that end. Additionally, Karen is working with CalMHSA to get all counties using our local line to share in the cost based on call volume.

Legislative Hearing on Medi-Cal Mental Health Delivery System

Over the past month there have been 7 hearings related to mental health services in California. There is a great deal of interest at the state level in regards to mental health services, outcomes, and their financing statewide. Karen had the opportunity to testify at the March 5, Assembly and Senate Joint Health Committee hearing regarding the future of mental health service delivery.

Partnership Healthplan of California


On March 6, County staff and providers met with Partnership Healthplan and Beacon Health Strategies to discuss coordination of care between mild to moderate mental health and specialty mental health services. Drug Medi-Cal SUD Treatment Update

On March 26, HHSA Staff will present the Board of Supervisors with an update on Drug Medi-Cal Substance Use Treatment. The presentation will highlight program growth since the implementation of the Drug Medi-Cal Waiver as well as Results Based Accountability (RBA) outcome measures for July 1 2018 through December 31 2018. As background, on July 1st, 2018, Yolo County went live with expanded services under the Drug Medi-Cal Organized Delivery System (DMC-ODS), which allows for expanded Medi-Cal covered services. The DMC-ODS waiver has allowed Yolo County to increase services available to anyone eligible for Yolo County Medi-Cal and will include Withdrawal Management (Detoxification), Residential Treatment, Intensive Outpatient, Outpatient, Case Management, Physician Consultation, and Recovery Services. Additionally, the 1-888-965-6647 access/crisis line that previously served only mental health beneficiaries was

expanded on July 1st, 2018 to include screening, referral, and linkage to care for Drug Medi-Cal eligible services. This access line is available 24/7 for Yolo County Medi-Cal clients, and client can also walk into HHSA and CommuniCare. Locations in Davis, Woodland, and West Sacramento to receive the same screening, referral, and linkage services in person. Please see data below for RBA outcomes and further details. All data from July 1 2018 through December 31 2018.




Access log entries for the period of 07/01/2018 through 12/31/2018:

35% (921 contacts) of the total number of entered Access Log contacts (2617 contacts) where requesting SUD Services


653 ASAMS were entered into Avatar through an access point entry




Bi-Annually Reported Number of referrals/ coordination for other services and referral dispositions



Narcotic and Opioid Treatment: 60% Reduction in Days incarcerated while in treatment






