The applicants would like to adjust the property lines to create an agricultural home-site, the proposed lot line adjustment would result in a 4.383-acre home-site parcel and a 58.999-acre vineyard parcel. Because the home-site parcel is made nonconforming, it requires a zone change from Agricultural Intensive (A-N) to Agricultural Residential (A-R). This is a discretionary action that requires Board of Supervisors approval because of the zone change. (Planner: C.Tschudin)
