Yolo County - Marissa Juhler

 Yolo County Landfill is preparing Franchise Agreements, Household Hazardous Waste contract and an RFP for E-Waste.

Yolo County - Ramin Yazdani

- Yolo County Landfill had their bid opening for the next landfill module, all bids were rejected. Project was advertised again and bids were received. We're working with the county counsel to go over some issues we had with the bids. The contract will be awarded to low bidder on April 23, 2019.
- In Vessel Digester project the floating cover pond portion of the project is close to completion. Request for bids on the tank portion will be released once I finish reviewing the plans. The concrete pad for this project should be going out to bid in a few weeks.
- Closure of units 4&5 request for bids have been posted for the closure of units 4&5. The bids will be coming in at the end of April.
- PG&E update Yolo County Landfill still has not received any plans back from PG&E.
 We are expecting the plans back by next few weeks. Project has been delayed as a result of PG&E delays.
- We received tire grant from CalRecycle for \$330,000. This will be used to purchase and install shredded tires for the operations layer of next landfill module (6F).
