June 19, 2001

#### MINUTES

The Yolo County Board of Supervisors met on the 19th day of June, 2001 in regular session in its Chambers in the Erwin Meier Administration Center, Woodland, California at 9:00 A.M. pursuant to County Code Section 2-1.103.\* Present were Supervisors Rosenberg, Pollock, McGowan, Wolk and Chair Stallard. Chair Stallard presided. Victor Singh, County Administrator and Steve Basha, County Counsel were present. Auditor-Controller Howard Newens led all in attendance in the Pledge of Allegiance to the Flag.

Brenda Cedarblade, business owner in downtown Woodland, expressed her concern relative to the location selected to build the new wayfarer center in the City of Woodland and the effect she felt it would have on her business.
