Stepping Up Initiative Position Proposals - HHSA

Through the year-long process of Stepping Up sub-committee discussions, Intercept group team members were able to determine current gaps in the Yolo County continuum of care for the justice involved population with mental health conditions who are experiencing repeat cycles of incarceration due to those gaps. Leads of the sub-committees prioritized the gap areas and have developed position proposals to best address the highest priority gap areas.

Each of these positions would exist with Yolo County Health & Human Services Agency (HHSA) in the newly developed (pending Bargaining Unit and Board of Supervisor approval) "Behavioral Health Case Manager" classifications (see attached). Central to the functioning of each position will be a strong working knowledge and relationship with a broad continuum of agencies and services throughout Yolo County.

Criminal Justice Re-Entry Coordinator (1 FTE) – Behavioral Health Case Manager III

 This staff position will work with in-custody individuals and community-based partner agencies to increase post-release service linkage, including linkage to behavioral and physical health, housing and self-sufficiency opportunities.

Criminal Justice System Navigators (3 FTE) – Beahvioral Health Case Manager II

These staff positions will receive individuals at time of exit from custody to improve successful linkages to community-based partners. The Navigators will assist individuals to all three primary jurisdictions in the County – Woodland, Davis and West Sacramento. The highest recidivism risk individuals will also be navigated to direct linkage with the Criminal Justice Case Manager.

Criminal Justice Case Manager (1 FTE) - Beahvioral Health Case Manager II

 This staff position will provide direct assistance to the highest recidivism risk individuals targeting engagement with community-based services appropriate to their behavioral and physical health, housing and self-sufficiency needs.

Specialty Court Case Manager (1 FTE) - Beahvioral Health Case Manager II

 This staff position will support an increase in the number of Mental Health and Addiction Intervention Court enrollment to 40 individuals.

Stepping Up Initiative Position Proposals - Probation

Through the year-long process of Stepping Up sub-committee discussions, Intercept group team members were able to determine current gaps in the Yolo County continuum of care for the justice involved population with mental health conditions who are experiencing repeat cycles of incarceration due to those gaps. Leads of the sub-committees prioritized the gap areas and have developed position proposals to best address the highest priority gap areas.

The below position would exist with Yolo County Probation Department. Please see the attached email for more information regarding costs and position classification.

Specialty Court Probation Officer (1 FTE)

- This position will support an overall increase in the number of enrolled individuals in the Yolo County Specialty Courts (Addiction Intervention Court and Mental Health Court)
- Manage a probation caseload of 20 probationers engaged in one of the two Yolo County Specialty Courts (AIC or MHC)
- Be cross-trained in both courts policies, procedures, and practices for coverage purposes when the other Specialty Court PO is unavailable for court appearances or client services
- Act as the Probation liaison to the Specialty Court team for which that officer is assigned (court appearances, conduct Probation assessments, coordinate with other Specialty Court departments and their staff)

OVERVIEW

SyTech Solutions is pleased to submit this informal budget estimate for the development of an interconnect platform to connect various systems for the purposes of managed data sharing. The schema of the data shared between the systems has yet to be identified and will likely evolve. To handle this changing structure, the platform will include schema management, granular permissions controls at the property level, and effective access reporting. A standardized REST API will be developed to provide a common interface to develop 3rd party application hooks. Included are estimated annual costs for high availability hosting in Microsoft Azure. We feel confident that this project would result in a "quick win" and provide both the platform and proof of concept for the remaining workflows.

PRICING

The costs listed below provide a non-itemized estimate for the development costs of the interconnect platform as well as the annual cost to host such a platform in the cloud. This estimate includes configuration for two interconnects to support the first data flow between two distinct systems. Additional development costs will be necessary to configure new interconnects. Hosting costs will be adjusted as needed to support additional throughput and availability as the system grows.
