CALL TO ORDER

- **1. Welcome and Introductions:** The March 25, 2019 meeting of the Local Mental Health Board was called to order at 7:00 PM. Introductions were made.
- 2. Public Comment: Linda Wight wanted thank the board and James for all the advocacy that LMHB does. Encouraged audience to join NAMI walks and express sincere appreciation for all the help HHSA has provided her.
- 3. Approval of Agenda: Motion to approve from Richard, second by John.
- **4. Approval Minutes**: Minutes approved with comment from Richard as a request for the more information from regarding the Mental Health Court.
- 5. Member Announcements:
 - a. James wanted to provide a moment of silence for Noah who recently passed.
 - b. Antonia announced that the system helped her recently get through a difficult time recently and she's glad the system is working.
 - Bret Bradley expressed gratitude for having Jonathon Raven on the LMHB.
 James agreed and feels fortunate to have the Johnathon, Bret and Sheriff
 Lopez here.
 - d. Jonathon introduced himself and shared his connections with the LMHB as both an advocate and consumer.

- 7. Sheriff Lopez presented an update on the Jail Construction and CIT training.

- 8. Mental Health Director's Report by Karen Larsen, Mental Health Director, HHSA
 - a. Pine Tree Gardens-
 - 1. Nicki asked about Pine Tree Gardens and Supervisor Saylor expressed his sincere concerns regarding the people that live that there. He knows the community needs to exist and he believes that the meetings will cut down on mis-communications and will help bring people together. Nicki said the people don't understand the money situation. Supervisor Saylor would like to have a conversation with same people so we can all have a shared understanding of the conversation. Supervisor Saylor expressed how complicated the situation is and that Turning Point is not the operator. There are two operators who run the daily operations. Statewide facilities like PTG are closing because there's not state funding to keep them going. We think there's a statewide need for this and we're thinking about doing some legislative advocacy. Nicki wants to know what the state maximum is for Board and Care. Antonia said she believes that Turning Point has to charge the minimum (about \$1100/month) even if people have different income. Nicki wanted to look in to Regional Center funding and Karen mentioned that regional centers don't compare.

 - c. Suicide Prevention Sustainability Planning-

 - Nicki asked about how the presentation went. Karen talked about the plans include eliminating the carve out. Washing, Arizona, New York and Michigan have done its so we have some models to work from.
 - f. Partnership Health of California-
 - Antonia asked about Partnership Health Plan. Karen said that all Medi-Cal mild moderate are on Partnership Health in Woodland. During the expansion of Medi-Cal mild to moderate Partnership contracted with Beacon. When people come in for services we align them with level of care they need.
 - g. Yolo County Outpatient Mental Health Services Utilization: Woodland-
 - 1. Sally asked about similar numbers for West Sacramento regarding access. Samantha let her know there was typo on our staff's part and this information is only about Woodland.
 - h. Drug Medi-Cal SUD Treatment Update-

i. REGULAR AGENDA

Board of Supervisors Report – Supervisor Don Saylor

- a. Tomorrow (3.26) Board of Supervisor meeting Strategic Planning Process: Community Engagement presentation tomorrow. About 500 community members participated in the survey and data collection. Based on what Sup Saylor has seen so far, homelessness, and mental health are big priorities.
- b. Pacifico: Overt the last couple months there are been many community meetings to discuss the licensed facilities. Pacifico was a privately owned dorm that is now owned by the City. The local residents are concerned about making it an adult residential facility and they delay jeopardizes the project timeline and financing. We want to do a lot of educating and information sharing to try to work with advocates. It's currently primarily operated by Yolo County Housing and tenants pay rent. Supervisor Saylor is optimistic that there's a path forward.
- c. Pacifico Navigation Center: Supervisor Saylor mentioned that it may not be the right place. Karen mentioned that the money for navigation is not tied to the funds for the Adult Residential Facility.

2. Chair Report – James Glica-Hernandez

- a. Call with CalBHBC
 - White paper: Emergency Preparedness. Email from Kristin Weivoda stated that the County has adopted a crisis response plan. It's not complete, but the County is actively working to improve and to be prepared for a response. James would like to have Kristin come visit.
 - Richard: Site visit Ad hoc: 9 places for Site Visits: Central Committee, Prioritize Visits to about 1 per month, committee would appoint a site visit leader, target 5 visitors (LMHB, NAMI members etc), the visitation leader would share out on the report.
 - a. James would like to know who else would like to participate in site visits? Nicki King, Antonia Tsobanoudis
 - 3. Brown Act Reminder: Please send everything to James or Brittany, then James can send out with his approval. Nicki confirmed that you can't email more than 3 people.
 - 4. Please make sure to complete your ethics training. If you've taken your ethics training, please copy your certificate and send it to Brittany.
 - 5. Mental Health Court Update: Bret and Jonathon- Jonathon participated in the Forensic Mental Health 43rd annual conference. He presented on the addiction and mental health court as well as all the restorative justice efforts. It was very exciting to have so many people in the audience and interested in starting the similar programs in their respective counties. Jonathon announced that there's a new judge (Dave) to replace Judge Guard. These systems require everyone to work together and it's a much happier place to be than

regular court. Jon feels like all the partners are evolving together to get people through the system and diverted from incarceration. We want to add numbers to these programs because there are still gaps. On an anecdotal basis these programs are remarkable. James asked if Jonathon and Bret and keep their eyes out for a potential former participant to join the LMHB.

6. Nicki wanted to know more about the innovation and incubator. Karen let her know that there are couple possible programs.

CALL TO ORDER

- **1. Welcome and Introductions:** The April 29, 2019 meeting of the Local Mental Health Board was called to order at 7:00 PM. Introductions were made.
- **2. Public Comment:** A Pine Tree Gardens advocate shared the importance of Pine Tree Gardens to her, her family and community.
- 3. Approval of Agenda: Approved
- **4. Approval Minutes**: Postpone approval of minutes to next Month, May 20th. Members to send edits to Brittany and new minutes will be shared prior to the next meeting.
- 5. Member Announcements:
 - a. Jonathan Raven- Announced work to increase the numbers of Mental Health Court participants as well the graduation taking place tomorrow (4/30/19).
- 6. Correspondence: None
- 7. Time Set Agenda: Rebecca Mellott presented an update on the HHSA FY 19/20 Budget.

CONSENT AGENDA

- 8. Mental Health Director's Report by Karen Larsen, Mental Health Director, HHSA
 - a. Mental Health Awareness Month

b. Suicide Prevention Crisis Line Sustainability

Karen shared that historically HHSA funded the line for \$100,000/year out of MHSA. They are mostly operated by volunteers but struggle each year to make ends meet. We're now asking that participatory counties contribute money to the crisis line operations. For 19/20 we're going proceed with Cal Mesa, our JPA for administering contracts for participatory counties.

c. Pine Tree Gardens (PTG)

Karen talked through the sustainability plan which was included in the agenda packet. Vice Chair, Nicki King, asked how the transition to FSP and PG clients would occur. She was wondering if it would occur by attrition or by other methods. Karen said that's unclear right now and understands that concerns regarding higher intensity clients. A member of the public from Pine Tree Gardens reported that there are many clients with needs beyond what can be provided by the current operators. Another public comment mentioned that what they heard in a previous meeting provided conflicting information with what they're hearing today and expressed concerns about assessment methods. She mentioned that assessments have been happening at Pine Tree Gardens and wonder what type of assessments those were. Karen clarified the misunderstanding and helped to explain what an assessment entails and FSP means. Sandra Sigrist also mentioned that CommuniCare was assisting with past due treatment plan assessments. The public commented that Yolo County is stricter with FSP rules than other counties. Karen acknowledge the comment and explained that Yolo County doesn't fund any Board and Care facilities in Yolo County, whereas other counties might have different relationships. Member, Antonia Tsobanoudis asked how the \$150,000 per year as outlined in the sustainability plan would be distributed and ask if it would require Deidra (a PTG operator) to do more paperwork as she does not have the bandwidth to add that responsibility. Karen replied that the \$150,000 per year is directed toward Turning Point, but Karen anticipates that more financial transparency will be required. Public comment on behalf of "Save Pine Tree Gardens" thanked the board and clarified the amount her family is offering in addition to the charity event they're planning to host. She would like to see the operators provide expenditures for both houses so that MHSA money can be appropriately allocated. Her family is likely to start a non-profit to help facilitate tax deductible contributions to better support Pine Tree Gardens. Nicki suggested use NAMI as a Fiscal Agent/Host so that Deidra's family could work under NAMI rather than get their own 501c3. Member, John Archuleta would like to see a clearer budget from the operators so that the facility can run more efficiently in the long run. Public comment thanked HHSA for the quality of the Day Treatment Programs at Pine Tree Gardens. She also asked how will FSP be defined and who will be conducting assessments. Karen explained that it's undecided at this point. Public comment stated that the operators will need more help if all residents become FSP and gave examples for why that would be. She wanted everyone to know that the operators need money and resources. Nicki redirected focus back to the agenda.

Mental Health Court information was shared by Member, Jonathan Raven. He stated that KCRA 3 took interest in our Mental Health Court and interviewed staff and participants. He encouraged everyone to watch the video linked in the Mental Health Director's Report.

Samantha Fusselman explained that the data shows what percentage of West Sacramento residents who need specialty mental health services are able to obtain them in their home City. She stated that in each meeting we've spotlighted a different major City, Davis, Woodland and now West Sacramento. She offered to provide data based on requests of the board. Member Maria Simas said she would get back Samantha with what information would be most helpful.

- c. Site Visits: Member, Richard Bellows contacted Napa LMHB and they only have two people attend per site visit. He was wondering if there was a confidentiality reason for that. He was wondering how many members can legally participate. Karen and Samantha said they will look into it. Nicki said she doesn't think we can do more than 3-4 visits/year. Richard stated that the committee needs to meet again to refine questions. Richard asked if the site visits first contact could be made by HHSA. Karen suggested that Samantha be the contact for that as she leads the QM team in visits to our providers.
- d. Additional Public Comment- Peace People from Davis: The representative came to discuss an incident with the Davis Police Department. She came to inform the board of multiple incidences where the Peace People of Davis

believe the Police need to more involved. Members Robert Schelen and Brad Bandley let the advocate know that the LMHB is here and welcomes public comment.

e. Mental Health Court KCRA video: The video will be watched at the next meeting.

3. Future Meeting Planning and Adjournment – Nicki King

MHSA Annual Update

 Annual Updates must be adopted by the county Board of Supervisors and submitted to the Mental Health Services Oversight and Accountability Commission (MHSOAC) within 30 days after board of supervisor adoption.







- Yolo is in a permit process with the city of Davis to locate the Adult Residential Treatment Program in a multi-building affordable housing complex
- Yolo completed a Board and Care Study with Innovation funds, supporting statewide efforts to increase mental health-based residential programs

Item 8. Mental Health Director's Report

Local Mental Health Board

Director's Report

May 20, 2019

Mental Health Month Events – The month of May is filled with a variety of Mental Health Awareness events including a Consumer Art Show, a Family Carnival and more. Please see attached calendar of events. Additionally, the City of West Sacramento requested information regarding the state of Mental Health in Yolo County and used the data to create a proclamation declaring May 2019 as Mental Health Awareness Month. Karen and Local Mental Health Board Members James, Maria and Sally were invited to receive the proclamation which was signed and presented, on May 17th at the City Council Meeting. Likewise, the Yolo County Board of Supervisors will present a resolution in support of Mental Health and Maternal Mental Health Awareness on May 21st. Local Mental Health Board Chair, James will receive the resolution.

Pine Tree Gardens Advocacy- On May 9th, Yolo County sent a letter supporting the Steinberg Institute's request of \$18 million in funding, per year, for three years, to supplement the current reimbursement rate paid to licensed residential facilities serving a population of Californians with severe and persistent mental illness (with primary psychotic disorder) experiencing homelessness, or at risk of homelessness. This initial investment of \$18 million per year for three years will provide an immediate infusion of resources into the system while longer-term, moresustainable solutions to this underfunding crisis can be developed. Please see attached letter.

Pacifico- The County Administrator's Office, HHSA and City of Davis are continuing with efforts to move the Pacifico Adult Residential Facility (ARF) project forward. On May 14th, the Davis City Council heard an item to address existing safety concerns on the campus. Once those issues are addressed, the ARF project can start moving through the City's conditional use permit process. To address concerns of residents in the neighborhood surrounding Pacifico. Communicare is now searching for an alternate 5/day per week location for the Navigation Center.

Medication Assisted Treatment- There have been several efforts to expand access to Medication Assisted Treatment (MAT) for Yolo County residents over the past year. As part of launching the Drug Medi-Cal Organized Delivery System (DMC-ODS) waiver July 1st, Yolo County contracted with 2 Narcotic Treatment Program (NTP) providers (CORE Medical and BayMark Clinics) with a total of 4 locations (3 in Sacramento and 1 in Fairfield). Prior to this launch, CommuniCare Health Centers and CORE Medical were awarded a Hub & Spoke grant through the Department of Healthcare Services to expand MAT access and a requirement of this grant was to open an NTP within the County borders. To continue access expansion and meet the needs of the Hub & Spoke grant, CORE Medical will be opening a West Sacramento site at 3990 Industrial Blvd West Sacramento CA 95691 in the next few weeks. They have passed their DEA and Drug Medical site reviews, are hiring staff, and will open doors shortly. As a reminder, to get into substance use services with Yolo County, a client can call 1-888-965-6647.

SAB-G/DMC ODS Audit- On May 8th and 9th, HHSA staff hosted reviewers from the Department of Healthcare Services (DHCS) for our annual substance use audit. The Substance Abuse Block Grant (SABG) and Drug Medi-Cal Organized Delivery System (DMC-ODS) Waiver are the two main funding streams for Yolo County clients needing substance use treatment. This was the first year Yolo County was participating in the DMC-ODS waiver which has had, and continues to have, many changes from the state and federal levels, so staff were unsure exactly which requirements the department would focus on. There were 41 items included in the SABG review and 65 in the DMC-ODS review, many with additional components within each item. Preliminary results provided by DHCS show that Yolo County was 95% in compliance with the SABG items and 91% in compliance with the DMC-ODS items. HHSA staff anticipates being in full compliance with the SABG requirements and over 95% in compliance with DMC-ODS items within 30 days.

Governor's May Revise -

Whole Person Care

The May Revision includes an additional \$20 million in one-time funding (Mental Health Services Fund) over five years to expand Whole Person Care to counties that do not currently operate a pilot. This proposed investment is in addition to the \$100 million in the Governor's January budget.

Peer-Run Mental Health Crisis Line

The May Revision includes \$3.6 million (Mental Health Services Fund) annually for three years to provide support for a statewide peer-run mental health crisis line.

Substance Use Disorder

The May Revision includes \$21.5 million in Proposition 64 funds for competitive grants to develop and implement new youth programs in the areas of education, prevention and early intervention of substance use disorders. The funds are continuously appropriated.

Council on Criminal Justice and Behavioral Health Juvenile Justice Roundtable -

The Council on Criminal Justice and Behavioral Health (CCJBH) hosted Juvenile Justice Roundtable of subject matter experts on April 30th. Karen was on the morning panel and addressed the link between trauma and criminal justice involvement. This event was facilitated by CCJBH Council Member Mack Jenkins, former Chief Probation Officer, San Diego County. The objective of the juvenile justice roundtable was to gather insight from experts regarding critical issues affecting youth who are justice involved and struggling with serious substance use and mental health disorders. Presenters focused on priority issues which included the link between juvenile justice and homelessness, issues impacting LGBTQ youth, the significant racial and ethnic disparities in the juvenile justice system, and youth with incarcerated parents.

Homeless PIT Count draft report- HHSA staff submitted the 2019 sheltered and unsheltered report to Housing and Urban Development (HUD) by the due date of April 30th. Additionally, staff has worked with Homelessness and Poverty Action Coalition (HPAC) on a draft 2019 Point in Time County Report which provides much more in depth analysis of the survey results than HUD requires. The format is based off the 2017 report which can be found here, https://www.yolocounty.org/home/showdocument?id=55899, and will be finalized after an upcoming review by HPAC staff. Countywide, the overall sheltered and unsheltered count went from 459 in 2017 to 655 in 2019, with an increase in unsheltered from 209 in 2017 to 397 in 2019. This report is the result of a number of county, city, and provider staff dedicating time to not only survey administration on the night of the count, but on reviewing information and ensuring accuracy.

Forensic ACT Team RFP – In late June, HHSA is planning to release a Request for Proposals to implement a Forensic Assertive Community Act (F-ACT) Team. The target population for these services will be seriously mentally ill adults who meet the criteria for Full Service Partnership, are living homeless or who have a history of homelessness, and who are involved in the criminal justice system. The program will maintain an enrollment of 50 individuals. It is hoped that services will start by January, 2020.

Children's Mental Health –


- The HHSA Child Youth and Family Branch hired a Deputy Director who will start on June 10th. The new Deputy Director, Karleen Jakowski, was the Deputy Director of Health and Human Services for Yuba County, overseeing Child Welfare, Adult Services and CalWORKS Employment Services. In her new role with Yolo County HHSA, Karleen will oversee the Children's Medical Services program, Children's Mental Health and the CQI team.
- To fully integrate HHSA's mental health services available to youth and young adults in Yolo County, the Transition Age Youth (TAY) Mental Health team will transition to HHSA's Child, Youth & Family (CYF) Branch. This move will support youth in the children's mental

health system to receive comprehensive care from their early teen years, through their 20's when needed.

2019/2020 Strategic Plan HHSA Executive Leadership Team has finalized the FY2019/20 Agency Strategic Plan. Please attached plan.

Social Security Income (SSI) Cash Out- With the implementation of the Social Security Income (SSI) Cash-out or CalFresh Expansion, starting June 1 2019, many Yolo County seniors and disabled residents who were previously ineligible for CalFresh may now qualify. CalFresh provides low income families and individuals with financial means to purchase healthy and nutritious food. Prior to this change, SSI recipients were precluded from receiving CalFresh benefits. SSI recipients will now qualify for benefits ranging from \$15 to \$195 per month depending on income and other eligibility factors. Today in Yolo County, we have a little over 17,000 residents on CalFresh and we're anticipating that this change will increase those who are eligible by 5,000. Due to this significant growth in potential recipients, the HHSA Service Center Branch has been gearing up with additional staff, resources, outreach and trainings to meet this increased demand.









RE: Budget Request - Preserving the Safety Net for Low-income People with Mental Illness, and Preventing Homelessness

Dear Chairs Pan and Reyes,

Yolo County supports the Steinberg Institute's request of \$18 million in funding, per year, for three years, to supplement the current reimbursement rate paid to licensed residential facilities serving a population of Californians with severe and persistent mental illness (with primary psychotic disorder) experiencing homelessness, or at risk of homelessness.

Statewide, this funding would increase reimbursement rates for 1,500 people. This three-year request is intended as an initial investment to address the immediate, urgent need to infuse resources into this system of care; due to chronic underfunding, facilities have been closing and licensed beds are being lost permanently. On July 1, 2019, when minimum wage increases, we anticipate a significant increase in these closures statewide. Raising the reimbursement rate from \$1,058 to \$2,058 would ensure residential facilities in Yolo County could sustainably continue to accept and care for this vulnerable population. This initial investment of \$18 million per year for three years will provide an immediate infusion of resources into the system while longer-term, more-sustainable solutions to this underfunding crisis can be developed.

For these reasons, Yolo County urges your support.
