Summer 2018	Subset of community requests reconsideration of wells and POU option; County (at own expense) further evaluates a variety of options and again determines City connection the most viable
10/04/18	Wolstoncroft v. Yolo filed to invalidate 03/20/18 fee increase pledged to repay SRF loan
12/20/18	State halts consideration of CSA's SRF loan application
02/21/19	NDM informed revenue for current operations insufficient and services may need to be cut if lawsuit not soon resolved
04/30/19	NDM informed revenue sufficient only for water service; other services to discontinue in 2019-20 unless Prop 218 proceedings successful for new landscaping, street lighting and stormwater fees
05/09/19	Letter received from Chief Financial Officer notifying the CSA it no longer has sufficient unrestricted cash to pay operational expenses and has exceeded its borrowing authority.
