4. PUBLIC COMMENT

- 5. STATE AND COUNTY UPDATE Jill Cook, County Administrator's Office
  - **Budget:** The Governor has a press conference at 10:30 this morning to release his May Revise. Some significant changes that concerns health, which is the Public Health Realignment.
- 6. BOARD OF SUPERVISORS UPDATE Jessica Jones, Assistant Deputy to Supervisor Saylor, District 2
  - **Strategic Plan:** At the Strategic Plan Workshop, the Board identified five 2020 Strategic Plan Goals which include: Thriving Residents, Safe Communities, Sustainable Environment, Flourishing Agriculture and Robust Economy. The next Strategic Plan Workshop will be held on July 16<sup>th</sup> and will focus on Agriculture, the Environment and the Economy along with a status update on the 2016-19 Strategic Plan.
  - General Assistance Program: General Assistance provides temporary relief for Yolo County residents who
    have exhausted all other means of support. The Board supported the proposal to increase benefits to \$328.00,
    by increasing the benefits, this aligns us with partner counties. The Board also supported the proposal to
    expand housing benefits to include hotels. The final resolution will be brought back to the Board at their June
    meeting.

• **Upcoming Events:** On May 14<sup>th</sup> The Community Services Action Board will hold a public hearing to receive input on its two-year plan to better address the needs of low-income individuals and families that reside in Yolo County. The public hearing is from 5-5:30pm in the Thomson Room at the Bauer Building.

May is Mental Health Awareness Month and Health and Human Services Agency will be hosting the following events: May 17<sup>th</sup>, Art Show from 11am-1pm, at the Civic Center in West Sacramento City Hall; May 28<sup>th</sup>, Child, Youth and Transitional Age Youth Carnival from 4pm-7pm, at 137 N. Cottonwood Street, Woodland; May 30<sup>th</sup>, Art Show from 11am-4pm, at 137 N. Cottonwood Street, Woodland.

On May 21<sup>st</sup> Esparto Park and Aquatic Center will have their Ribbon Cutting ceremony. The Aquatic Center is located at 17257 Yolo Avenue in Esparto, the ceremony has been scheduled to begin at 4pm.

# 7. COMMUNITY HEALTH BRANCH REPORT — Brian Vaughn, Public Health Director Branch Report

- **Flavored Tobacco:** The team is currently meeting with the Cities of Davis and West Sacramento, and potentially attending a council meeting in West Sacramento asking them to consider a flavored tobacco ban to match the county's unincorporated areas.
- SNAP-Ed Program: The state-wide Supplemental Nutrition Assistant Program Education (SNAP-Ed) formerly known as Nutrition Education Obesity Prevention (NEOP), will now be called CalFresh Healthy Living. This name change is part of a state-wide effort to show the community how CalFresh and its nutrition/obesity prevention program counterparts are all part of a comprehensive system to support low-income residents in making healthy food choices for their families.
- WIC: Today we will be hosting a Mother's Day Tea Party for pregnant and breastfeeding mothers.

  The WIC Card has been delayed a month due to computer glitches for the pilot counties. Yolo County still has a rollout date of September 23<sup>rd</sup>, there is a Federal mandate to be in place statewide by Spring of 2020.
- **Health in All Policies (HiAP):** Brian and Dr. Chapman presented HiAP at the Davis City Council meeting. The Council was very receptive and talked about including a health component in their general plan, and they were looking for way to start assessing health in some of their future decision making.

Brian and Dr. Chapman will also be going to West Sacramento to give a HiAP presentation at their 2x2 meeting.

- 8. HEALTH OFFICER REPORT Mary Ann Limbos, Deputy Health Officer
  - Measles: No active cases in Yolo County as of today. As of last week, the CDC announced there are 764 cases in 23 states; and in 40 cases California. The county is focusing on education and trying to develop a response in the event that we do have an active case of Measles. There was an advisory sent out specifically to the school nurses advising about the outbreak in Sacramento; and the Healthy Schools Collaborative focused on a table top training for schools. The county now has a Measles website that can be found at the County's homepage, under the "In the Spotlight" area there is a direct link to the webpage.
