

# HISTORY OF THE CACHE CREEK AREA PLAN

- Rivershed management plan adopted in 1996
- Regulates off-channel mining and in-channel restoration along the Lower Cache Creek corridor
- Plan boundary = 28,130 acres (State MRZ land)
- 7 approved off-channel operations



# SUMMARY OF CACHE CREEK AREA PLAN UPDATE PROJECT

- Proposed changes to the program's 3 plans and 5 ordinances
- Update is a mandatory component of the program (adaptive management)
- Informed by 2017 Technical Studies

# TYPES OF PROPOSED PROGRAM CHANGES

- Updates to history and regulations
- Errata and clarifications
- Substantive changes

# KEY PROPOSED PROGRAM CHANGES

- Change in-channel material removal limit to reflect depositions trends (210,000 tons to 690,800 tons annually)
- Identify expanded future mining area (+1,188 acres SGR to existing 1,001 acres)
- 50-year horizon year (from 2026 with 2046 outlook to 2068)

# SUMMARY OF DRAFT EIR IMPACT ANALYSIS

- Most impacts fully mitigated
- Unavoidable impacts in 6 areas
  - Cumulative Aesthetics
  - Agriculture (project level & cumulative)
  - Air Quality (project level & cumulative)
  - Greenhouse Gases (project level & cumulative)
  - Cumulative Noise
  - Cumulative Traffic (truck trips)
