(Resolution Ordering the Improvements, and the Formation of the Clarksburg Lighting Assessment District and Confirming the Diaghram and Assessment and Constituting Levy of an Assessment)

WHEREAS, also on July 13, 1982, this Board adopted Resolution No. 82-94, Resolution of Intention to Form the Clarksburg Lighting Assessment District; and

WHEREAS, that Resolution of Intention ordered a public hearing to be held upon the question of the formation of the assessment district and the levy of the proposed assessment to be held at the hour of 11:00 a.m. on August 10, 1982, at the Chambers of the Board of Supervisors of the County of Yolo, Room 207, 725 Court Street, Courthouse, Woodland, California and directed the clerk of this Board to give notice of the hearing by causing the resolution to be published, posted and mailed as provided by California Streets and Highways Code Section 22556; and

WHEREAS, the clerk of this Board gave notice of that public hearing in the matter prescribed by law; and

WHEREAS, at the time set for the public hearing and at the location set

- This Board of Supervisors finds that each of the foregoing recitals is true and correct and that all proceedings taken for the Clarksburg Lighting Assessment District have been undertaken in the manner prescribed by law.
- It is determined that no majority protest exists.
- 3. The improvements for which the District was proposed to be formed are hereby ordered, said improvements consisting of the installation or construction of public lighting facilities, the installation and construction of any facilities which are pertinent to the foregoing or which are necessary or convenient for the maintenance or serving thereof, or both, of the foregoing.
- 4. This Board hereby orders the formation of the Clarksburg Lighting Assessment District.
- 5. The report of the engineer as on file with the Clerk of this Board,

including the diagram and assessment forming a part thereof, is hereby confirmed as filed.

6. The adoption of this resolution constitutes the levy of an assessment for the 1982-83 fiscal year in the manner set forth in the report of engineer.
