- Project Selection: Live Poll
 - o Brief review of collective impact and the feasibility framework to encourage participants to select a project that fits within the framework of Collective Impact.
 - o Poll presented 4 options varying in specificity and scope participants voted in live time to select the final project.
 - 1. Increase food security for Yolo County residents.
 - 2. Increase food security for Yolo County residents who receive Supplemental Security Income (SSI).
 - 3. Increase applications for enrolling those who are Cal Fresh eligible into Cal Fresh Benefits.
 - 4. Enroll 50% of Supplemental Security Income (SSI) recipients who are newly eligible for Cal Fresh in Yolo County.
 - o With 67% the participants voted to adopt the project to "Enroll 50% of Supplement Security Income (SSI) recipients who are newly eligible for Cal Fresh in Yolo County."

Defining Shared Project Goals

- How does the chosen project fit the Collective Impact Feasibility Framework?
 - Specific Social Issue to focus on in the community? Cal Fresh Enrollment of participants who receive Supplemental Security Income (SSI).
 - o Actors in the System who can influence the social problem? All Healthy Yolo participants
 - o Is collective impact the most appropriate solution for solving this problem? No, however it was agreed upon that although this is not a traditional collective impact project it will be approached as a shared project where we can learn what is needed to work together to achieve a shared goal where each partner will clearly defined the actions they will take to contribute and track their efforts with the hope that all contributions will result in an increase of a 50% increase in Cal Fresh enrollment.
