SUBJECT: APPROVE RESOLUTION FOR SECTION 8 MANAGEMENT

ASSESSMENT PROGRAM (SEMAP) CERTIFICATION

RECOMMENDED ACTIONS:

That the Board of Commissioners:

1. Adopt resolution approving the Yolo County Housing (YCH) Self-Certification score for Section 8 Management Assessment Program (SEMAP) Certification and Analysis for Fiscal Year 2007-2008.

BACKGROUND / DISCUSSION

SEMAP is designed to assess whether the Housing Choice Voucher tenant based assistance programs operate to help eligible families afford decent rental units at the correct subsidy cost. It also provides a system for HUD to measure public housing agency (PHA) performance in key HCV program areas and to assign performance ratings. There are fourteen indicators which are used to assign the performance ratings in the fourteen program areas. There is a maximum of 145 points or 150 with bonus points.

After completion of the self assessment, staff finds that it scores 120 out of the possible 145 points, making it a standard performer. However, the YCH continues to be rated a "troubled" agency by HUD with an active Corrective Action Plan (CAP) in place. Because of this, HUD is required by statute to continue rating the YCH as troubled until such time as HUD performs an on-site confirmatory review of the program and is able to remove the troubled agency designation.

FISCAL IMPACT

None at this time. Failure to certify SEMAP could result in financial penalties to the Agency, which are unknown at this time.

CONCLUSION

Staff has completed the necessary paperwork and back-up to successfully submit SEMAP information to HUD. HUD requires that YCH submit a self-certification of SEMAP indicators within 60 days after the Yolo County's year end of June 30, 2008. Once approved by the Board of Commissioners, the attached certification will be submitted on or before the due date of August 30, 2008.
