1. Call to Order and Introductions – The June 10, 2019, meeting of the Community Corrections Partnership (CCP) was called to order at 1:31 pm.

  5. Updates from Criminal Justice Grant Writing Group – (Bulkeley) (Attachment B) (Attachment C) -

*Mr. Bulkeley provided the update on the Criminal Justice Grant Writing workgroup. Below is the list of grants that are currently in process. Updates will be provided monthly. All members received.*

6. Updates from California State Association of Counties (CSAC) Results First Partnership (Fruchtenicht) -

*Chief Fruchtenicht provided the update on the CSAC partnership. Currently, focusing on Recidivism Study Group and Program Inventory Group. The next partnership group meeting is June 17<sup>th</sup> and will include working on Program Inventory stats and inventory details. Next up, will be looking at the Resource Cost Group with all partners including Courts. CAO Blacklock expressed kudos to all stakeholders for their hard work with the CSAC partnership. Chief Fruchtenicht will provide ongoing updates.*

7. Create public roundtable CCP meeting schedule for Fiscal Year 2019/20 (Fruchtenicht) –

*Chief Fruchtenicht would like to create public CCP roundtable meetings to discuss ideas, suggestions etc. Discussed possibly holding three meetings per year, with outreach to all Yolo County cities including rural areas. The meetings would be publicized as well as consider live streaming. As a group we'll work on this over the next few months and discuss in the near future.*

8. Action Item – Consider providing matching funding for the Justice and Mental Health Collaboration program Grant through the CCP budget. (Fruchtenicht) (Attachment D) and (Attachment E) -

*Deputy District Attorney, Jonathan Raven outlined the Justice and Mental Health Collaboration program. The Justice and Mental Health Collaboration Grant if awarded will be applied to our Mental Health Court. Total of the grant applied for is up to \$750,000 which requires a 20% match in years 1 – 2, and 40% match in year 3. The award notification date will be September 30, 2019 at the latest. If the grant is not awarded, the CCP will use the \$228,000 for both Addiction Intervention Court and the Mental Health Court. The \$228,000 will be funded through the CCP which was allocated from our strategic plan and approved in May 2019. All members voted on the funding proposals as outlined above. Motion: Tracie Olson, second: John Miller. Vote: Passes unanimously 5:0*

9. Provide direction for CCP fiscal year 2019-20 budget (Fruchtenicht) (Attachment D) (Attachment E)

*Chief Fruchtenicht outlined the CCP Fiscal Year 2019/20 requested budget. All members received handouts. Roundtable discussion on a few objective items regarding change of titles of the specific line items. All members agree that we will place an asterisk next to the objective line item. This will allow no amendments to the CCP Strategic Plan currently in place.*
