Member Updates

Yolo County - Ramin Yazdani

- Organic Waste/Composting Anaerobic Digestion Update: Diversion Services for Sacramento Area Organic Waste and Agreement for a Regional Composting Facility at Yolo County Central Landfill
 - County and Northern submitted an RFP on May 9th
- County and Northern Recycling long-term agreement and short-term agreement
- Landfill Construction and Closure: RJ Gordon started construction of Waste Management (WM) 6F

- County working with consultant (KNN Public Finance) on bond to finance the construction of Module 6F landfill
- RJ Gordon will be submitting the construction schedule for closure of Waste Management Unit 4 &5
- CalRecycle resolution was signed which allows access to closure funds to pay for the construction of landfill closure Waste Management Unit 4 &5
- Proposed Landfill and Esparto Transfer Station master fee changes. Changes go into effect July 1, 2019 (see attached final draft master fees)

Yolo County – Marissa Juhler

 Mattress Recycling Program: On May 1st Yolo County submitted its annual report for our Mattress Recycling program showing 13,091 units were recycled and 913 were landfilled. To minimize the amount landfilled, County added the Esparto Transfer Station to the Mattress Recycling program this past February so all units will now get recycled out there as well.

Davis - Richard Tsai

- Davis is in the planning stages of the "Apartment move out Waste Reduction Program".
- Davis and Recology are in the process of making schedule changes that will affect the "Loose in the Street" green waste collection program.

West Sacramento - Paulina Benner

• No Updates

Winters - Carol Scianna

- Winters went to City Council: \$10.99 per contamination or overage incident charges will be implemented by Waste Management beginning in June.
- Winters is still having an issue with green waste pickup.

Woodland - Rosie Ledesma

• Woodland's bulky waste event brought in 938 customers. This is much higher than last year.

UC Davis – Michael Fan

• Bio-digester has been working since January. The rates have been approved so now we can go public.

- Some of the grant money received by the Yolo County Food Bank will be going toward education. MAC will be in charge of educating the Tier 1 grocers and Tier 2 restaurants.
- Propane cylinder exchange: The event was a success with 103 cylinders exchanged for the refillable ones.
