

**ITEMS ACCEPTED IN  
MIXED LOADS AT C&D  
FACILITY**

In order to be accepted for recycling, each load must contain at least 65% by weight of the following materials:

**CARDBOARD (OCC)**

Styrofoam, film plastic & other contents of cardboard boxes must be removed

**DRYWALL (Gypsum Wallboard/Sheetrock)**

**INERTS**

Concrete / Asphalt/Bricks

Dirt / Soil / Gravel

Porcelain Sinks/Toilets/Counter Tops

Ceramic Floor Tile & Used Roof Tiles

**METALS**

Scrap Metals (including metal roofing)

Steel, Aluminum, Copper

Appliances - separate fees apply

**PLASTICS**

Plastics Coded #1, 2, 4, 5 and 7

**NOT ACCEPTED for RECYCLING:** - Fees apply

(PVC) Pipe #3

(PS) Styrofoam #6

Film Plastic/Shrink Wrap

**WOOD**

Lumber & Painted Wood

Branches & Green Waste

Pallets, logs, wood furniture/cabinets

Plywood, OSB, particle board

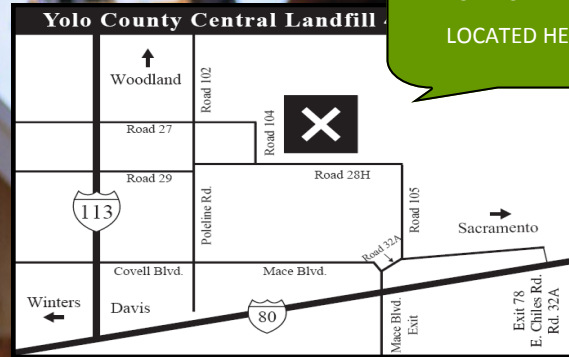

# YOLO COUNTY'S CONSTRUCTION AND DEMOLITION RECYCLING DEBRIS ORDINANCE



Effective January 1, 2017

**STOP!**

Before you start your next building project please review the diversion requirements under Ordinance No. 1375; Chapter 16, Title 6 of the Yolo County Code.

On June 24, 2008, the Yolo County Board of Supervisors adopted a Construction and Demolition (C&D) Ordinance that requires construction, demolition and renovation projects to dispose of their job site waste in an environmentally responsible manner. Yolo County's ordinance is in accordance with Assembly Bill (AB) 939.

The Yolo County ordinance is superseded by **CALGreen**—California's Green Building Standards Code. CALGreen promotes environmentally responsible, cost-effective, healthier places to live and work. The CALGreen building code waste diversion requirement as of **January 1, 2017** states that at least 65% of construction materials generated during new construction or demolition projects shall be diverted from the landfill. The County considers the reuse and recycling of C&D debris essential to compliance with AB939.

The Yolo County Landfill Construction /Demolition, Green Waste and Wood Facility helps contractors meet the new State CALGreen requirements. Studies show that nearly 22% of all waste disposed of in California is C&D debris. The reuse and recycling of C&D debris is essential to meet the diversion requirement of 65%.

<b>Agricultural</b>	All New	All New	Increase of conditioned area (including roofline changes to a barn) Under CALGreen standards, there are NO exemptions for ag related projects.
<b>Non-Residential</b>	All New	All New	Increase of conditioned area (including roofline changes to a business)
<b>Residential</b>	All New	All New	Increase of conditioned area (incl. roofline changes to a home)
<b>Subdivision</b>	All New	All New	Increase of conditioned area, volume or size

- ◆ **Window Replacements** No routing/No fee required.
- ◆ **Grading Projects** No routing/No fee required.
- ◆ **Roofing Projects** No routing/No fee required.
- ◆ **Green Houses** No routing/No fee required.
- ◆ **Pre-Fab Buildings/Barns** Route to IWM. No fee required. Need to obtain letter or invoice from manufacturer demonstrating pre-fab.
- ◆ **Hazardous Waste Projects** Route to IWM/No fee required
- ◆ **Patios/Pergolas/Carports** (Attached & Detached) – N/A (Not applicable because they are not conditioned area.)
