

## YOLO COUNTY LOCAL AGENCY FORMATION COMMISSION FEE SCHEDULE

**June 27, 2005**

Fees will be charged for all Commission proceedings and actions at the Commission's actual costs (including overhead). Billing will be based on hourly rates, with appropriate overhead costs. Fees due to the State of California will be paid by the applicant at the appropriate time and prior to final recordation of the Certificate of Completion.

All actions below are subject to the initial fees listed. (If a proceeding is not listed below, it will be subject to an initial fee as estimated by the Executive Officer.). An application deposit of \$2,000 is required for any application with an initial fee of that amount. If the amount of the initial fee listed is less, that amount will be paid upon submittal. A proposal with multiple actions requires a deposit for each action. Any additional expenses incurred by the Commission, in excess of the deposited amount, will be billed to and paid by the applicant before completion of the LAFCO proceedings, including final recordation and filings. If a proposal is abandoned or terminated for any reason (e.g., due to failure of a successful property tax agreement), the applicant will be refunded the deposit amount not expended prior to that termination point.

Request for waivers or exceptions to the fees must be submitted to the Commission for action.
