Member Updates

Yolo County - Ramin Yazdani

Organic Waste/Composting/Anaerobic Digestion Update:

- 1) In-Vessel Digester project update:
 - a. Bid for the "Equalization Mixing Tank and pH adjustment" and "Concrete Pad" was release. Bids are due on September 25, 2019. Project will be awarded for construction soon after.

- b. Food depackager will be shipped to the landfill and is scheduled to arrive on September 23, 2019. Installation of food depackager will happen once the concrete pad is completed in December 2019.
- c. The new metering pedestal was released for bid and bid results are expected by September 24th, 2019.
- d. Staff is working on electrical control panel for all equipment for in-vessel digester such as: pumps; food depackager; equalization tank and pH adjustment. Bid will be released by late September 2019.
- 2) Anaerobic Composter project update:
 - a. The installation of the leachate pump station electrical control panel was awarded to Butterfield Electrical (\$45,783) and will be completed by October 2019.
 - b. Anaerobic Composter cells are scheduled for waste acceptance by October 2019.
 - c. Contractor is currently working on the leachate and water line installation and work to be completed in end of September 2019.
 - d. PG&E has finally responded and we are working on an agreement to install new service to for the In-Vessel Digester and pump stations.
- 3) County and City of Sacramento and City of Folsom Organics RFP interview
 - a. Yolo County was selected as one of the potential site for acceptance of organic waste from Sacramento and Folsom. County and Northern Recycling meet with the city and county of Sacramento and City of Folsom and make a presentation and answered questions. The selection committee will get back to the County with additional questions and will respond in two to three months. County will sign a longterm agreement for organic waste.

Landfill Construction and Closure:

- 1) Construction of Waste Management Unit (WMU) 6F:
 - a. Installation of bottom liner and soil placement has been completed. Contractor working on clay liner install and primary liner installation. Some delays in liner install due to rain and clay liner testing.
- 2) County continues to work with consultants on bond finance for Module 6F landfill construction and other capital projects at the landfill. Bond approval is scheduled to go to BOS on October 22, 2019.
- 3) Closure of Waste Management Units 4 & 5:
 - a. Liner installation has started on 50% of the area. County has requested for partial closure to avoid potential rain event and damage to liner system and still waiting for RWQCB approval.
