Mark Wilson noted that the 25 MPH speed sign on Clarksburg Road driving eastbound into town is somewhat obscured by vegetation.

Anna Swenson wants a crosswalk in front of the Clarksburg Fire Department. Ms. Swenson is also concerned with traffic on Clarksburg Road.
