Jenny Tan, from the County Administrator's Office gave a presentation on the upcoming 2020 Census administered by the federal government, focusing on how those experiencing homelessness would be counted and what homeless service providers can do to assist.

## 6. SYSTEM PERFORMANCE DATA REPORTING

Emily Moran-Vogt announced that due to four systemwide data reports being due to HUD over the next six months, the Data Subcommittee recommended that a working group with HMIS Agency Leads be formed to prepare HMIS data for these reports. Emily will be reaching out to HMIS Partner Agencies to request names of designated individuals.

Jenny encouraged those interested in working as enumerators to apply with the US Census Bureau and they would be assigned to work in their community. She noted that the application process can take 2-3 months to be hired.

## 7. TAC RECOMMENDATIONS DISCUSSION

Ryan introduced topic of TAC Recommendations Report and noted that there was a draft Subcommittee Roles and Responsibilities report to provide guidance around one of the TAC recommendations. Ryan noted that the CoC often lacks the opportunity to have a good conversation due to limited time and encourages a robust discussion about how the CoC will move forward.

Attendees had a robust discussion of the TAC recommendations report. Some items that were clarified were decided on:

- Clarification was sought from consultants after the presentation because it was unclear which body had the power to make decisions about governance, and TAC responded that it was the CoC that had the authority to make decisions, and this applies to recommendation #7 to a certain extent.
- Clarification that even though CoC cannot assign work to other bodies, it can make recommendations to city officials and other groups on how those officials/bodies should interact with the homeless system, and the CoC does have the authority to determine how the CoC interacts with any other governing body that is created.
- Fewer meetings that are more specialized will allow people to be more involved in their areas of expertise.
- Page 11 of Homeless System Governance need for sufficient number of existing committees and participation to get the governance work of the body done and organized. Note that there's a lot of need to bring all the organizations together for information sharing and the second piece is governance and that is where the committees come into play.
- Technical Subcommittee participants support Recommendation #2 because of the amount of work needed and it's extremely important to capture the right talent and areas of expertise in the committees.
- Note that we are currently out of compliance with having a voting member with lived experience. Recommendation to recruit these individuals from those that providers work with.
- Note of the importance that to be able to implement recommendation #1 is that many more committees are needed to be able to develop policy.
- Need for greater participation in the CoC beyond just attending monthly general meetings and one subcommittee. For example, extremely important to do performance evaluation and oversight. Frustration about not know what the CoC's funding priorities are. Need to stop competing with each

other. Example given, CoC as a body has not talked about overall shelter strategy for the community, should we be having one centralized shelter? Should we have decentralized shelters? Need to determine these things so that we can effectively distribute funds.

- Issue that CoC functions on behalf of fund, how do we follow HUD rules and priorities that do not actually align with our local needs.
  - The State dollars are funding shelter and call out shelter as a priority.
  - This coalition is more than just HUD dollars, it is now also the mechanism for distributing State dollars so we need an overall strategy.
  - Note that Community Services Action Board (CSAB) conducts a community needs assessment to guide Community Services Block Grant (CSBG) funding, and CoC could do that too.
- Note that even though the HUD dollars are only about \$500,000, the State funding is utilizing HUD structure to guide funding.
- Agreement that we need more committees, statement that it is extremely important for the CoC to empower the committees. Expressed disagreement with the CoC undermining the committee recommendations.
  - The purpose of the committees is to examine a policy issue at a more detailed level than the overall CoC.
- Discussion of experience of students experiencing homelessness and the need to consider different models to address student homelessness. Recommendation to explore options based on population needs. Students want different solutions than older adults. Students in Davis care about access to internet, hygiene facilities, and safe parking. They don't care about having a house and all the costs associated with that.
- Importance to bridge the gap between decision makers and those experiencing homelessness.
- Concerns about governance and board roles and structures and desire for a well-considered approach to determine the most appropriate structure.
- Statement of need to establish committees now to complete immediate work needed and governance structure will take time to determine. There is work that needs to be now.
  - Support for implementing the low hanging fruit first, with making the County the HMIS Lead as an example.
- Desire to form a Governance committee.
