- 5.2 Primary CLUO Issues for Committee review.

5.2.1 The permissible proximity of cannabis operations relative to residential properties (including rural residential properties), schools, hospitals, churches, parks, retail businesses and other quasi-public facilities.

5.2.2 Odor concerns involving cultivation and drying.

5.2.3 County lands that could be available for cannabis operations, noting that even outdoor grows involve special above ground potting soils or hydroponics such that the quality of the parcel's soil may be irrelevant.

5.2.4 Maximum parcel size allowed for cannabis growth.

5.2.5 Whether permissible activities should be limited (e.g., to nursery operations, cultivation and processing to the exclusion of retailing, manufacturing and other business operations).
