### 4. PUBLIC COMMENT

#### 5. COMMUNITY HEALTH BRANCH REPORT - Anna Sutton

- Immunizations: We are well into flu season. We ran some statics last year, we looked at who we were vaccinating and who we were missing was our working families. They were unable to come into our flu clinics and our immunizations clinics. This year we switched our flu clinics to later hours, 4-7. We had higher turnout in West Sacramento and Winters. We're no longer holding our vaccine clinics and are referring families to their primary care physician. CommuniCare and Norther Valley Indian Health have been very helpful in helping get families in.
- **Breastfeeding Warm Line:** Our Warm line has been very busy. Please continue to encourage moms to call the breastfeeding warm line. It's a free resource that anyone can use. There is an IBCLC who staffs it.
- **Community Baby Shower:** This event is held every year with YCCA in Woodland. We had increase participation of families this year. There was a little over 200 people who attended.
- Emergency Preparedness: They have been doing a lot of drilling to ensure that they're ready for all of our emergency. With all the wind advisories and powering they are very active. If there is a loss of food due to a power outage, if you are receiving CalFresh, you have 10 days after the outage to fill out a CM303 and have the food replaced.
- **Syphilis:** Last year we 2 babies born with congenital syphilis. We've had one child this year born with congenital syphilis. We've put together a syphilis task force through a grant from CMSP. Part of the grant is to deploy rapid syphilis tests into the field to our partner organizations. Dr. Chapman's goal is to send a survey to all the organizations on the task force to ask if they are interested in the rapid syphilis test, the number of tests they might need, to order them, and get them out the first of the year.
- Brian Vaughn:
  - o **Flavored Tobacco** The Woodland City Council approved a ban on flavored tobacco, this is on top of the county ban in the unincorporated area. Woodland was pressured by their school board to do this due to the increase of vaping they were seeing in schools. This has pushed the other jurisdictions to push forward with the banned. West

Sacramento is going to consider a first reading for a flavor banned at the begging of December. We're currently talking with the City of Davis to get if on their agenda and have an informational session to introduce the topic to the council. The Winter's school board has also begun to put pressure on the City Council. We're hopeful that that within the next 6 months to a year, that they're will be a whole county banned on flavored tobacco.

- o **Mental Health Services Act** We've been working with Margaret, UC Davis. We will be holding a focus group with some UC Davis students to see how we might better fit their needs.

## 7. YOLO COUNTY CHILD WELFARE SERVICES PROGRAM UPDATES — CWS Staff

#### HANDOUT:

- CWS will receive a referral, the referral can have multiple allegations and multiple children.
- Once the allegation is determined it will be unfounded, inconclusive, substantiated
- Once it is substantiated it can go to either community services and does not have court intervention; if it has court
  intervention a case will be opened and they will work with family to get the children back
- In 2017 there were 2, 461 it went up to 2, 545 in 2018
- There has been a change when there is an allegation that a child has been hit, the siblings are no longer considered as at risk sibling, they are being placed into other categories
- There is no substantial change in the distribution of allegation, it is still mainly general neglect
- The 0-5 age group is the most crucial, they don't have the protective capacity, they make up the largest portion of our at risk youth and are our most vulnerable population
- General neglect allegations come in from mandated reporters, schools, doctors, and law enforcement
- CWS does partner with law enforcement but they are working on another project to have an automated sharing system
- There is a project in development to create a poverty map in order to look at different locations and compare them to substantiated referrals to determine if all of the neglect is from a certain poverty area

- Positive peer influence improving access and use
