9:00 A.M. CALL TO ORDER

1. WELCOME AND INTRODUCTIONS – Evan Priestley, Health Council Chair

The October 10, 2019 Health Council meeting was called to order at 9:05 a.m., at which time around the table introductions occurred and quorum was confirmed.

4. STATE AND COUNTY UPDATE – Jill Cook, County Administrator’s Office

- On September 24th, the Board of Supervisors adopted the County’s 2019-20 fiscal budget that also included a \$2.1 million funding proposal for Public Health Realignment associated spending plan.
- On October 1st, the Board held their Annual Strategic Planning Workshop that included the review of proposed outcomes, strategies and metrics. Staff will work on the feedback that was received from the Board; and the improved version will go back before the Board in November, at which time we will receive additional feedback and the final version will go to the Board in December.
- County Medical Services Program (CMSP) enrollment launched a new Path to Health program that would cover undocumented residents that are in need of limited scope primary care benefits. The Path to Health is intended to increase enrollment and access for the undocumented. CommuniCare Health Centers is the provider of health and have an approved application cap of 500 clients, and they currently have 363 enrolled.

5. BOARD OF SUPERVISORS UPDATE – Supervisor Saylor, District 2

- Yolo County is still in a high wind weather alert. PG&E has done some power outages in Yolo County in the Capay Valley and Winters area. If you are interested, the maps can be found [HERE](#) or on the Yolo County webpage www.yolocounty.org under “in the spotlight”.
- On October 8th the Board unanimously decided not renew the Office of Refugee Resettlement (ORR) contract, which will be ending at the end of January 2020. We are not accepting new placements, and we are currently working to find appropriate placements for the twelve children remaining.

- On September 24th the Board had a presentation and update on Microenterprise Home Kitchen Operations, and the Board chose not to “opt in” in the statewide program that is established by AB 626. There are many positive goals about the idea of allowing small business operations to prepare food in their homes and then sell it; but the challenge is there are a lot of food safety issues and environmental health concerns. The state legislation does not allow flexibility for counties to appropriately regulate the operations in a way that we can be confident.
- Saturday, October 12th, Pine Tree Gardens will be having a fundraising event to raise funds for the long-term sustainability for both long-term residential facilities in Davis.

6. COMMUNITY HEALTH BRANCH REPORT – *Brian Vaughn, Public Health Director*

- **Oral Health:** The program is expanding and primarily working in Davis and West Sacramento to increase oral health screenings for Kindergarteners and Third graders.
- **Tobacco:** Vaping and the lung diseases we are seeing are being monitored by the state. Happy to report that we have started the conversations with all four of the jurisdictions in the county, to potentially go forward together with a unified flavor ban to match what the county passed in 2017. The four jurisdictions include Davis, West Sacramento, Winters and Woodland.
- **Emergency Preparedness:** We just entered into agreement with the Fairgrounds for the Fairgrounds to provide shelter support incase of an emergency for both people and animals.
- **Centers for Disease Control (CDC):** The CDC came out with a report on sexually transmitted diseases this week where they announced gonorrhea, chlamydia and syphilis are at an all-time high. At a previous meeting Dr. Chapman reported the first time in 10 years the county having 2 cases of congenital syphilis; and the report for California is 332 cases in 2018 which is an increase of 20 percent from 2017.
- **Yolo County & CommuniCare Collaboration:** Yolo County and CommuniCare is launching an opioid coalition with the first meeting held on November 13th, Brian will send out an email with the information if you are interested in attending.
- **Mental Health Services Act (MHSA):** We are now in the three-year planning cycle for the MHSA funding. The funding requires that the county go out and talk with partners to develop a MHSA spending plan for the funds, set priorities, and we are currently in that process now. One of the requirements is for us to talk to health care providers, which one of the meetings will be held at the Maternal, Child and Adolescent Health Advisory meeting on October 16th from 10-11am.
- **Open Enrollment:** Just a reminder that open enrollment is kicking off October 13th and going through December 7th and encourage the people we are working with to get enrolled.
- **Geographic Information System (GIS) Days:** Every year the county hosts GIS days which is a system we use for mapping and looking at different ways to spatially view data from the county. This is an open meeting and will be held on November 14, from 10am-1pm, at 625 Court Street, Woodland.

7. HEALTH OFFICER REPORT – *Mary Ann Limbos, Deputy Health Officer*

- **Health Officer Report:** The [Health Officer Report](#) is usually sent to local healthcare providers; but this report was sent out by California Health Alert Network (CAHAN) just because the topics that are covered in it are important and timely.
- **Vaping:** As of October 1st, California has had 102 cases and 2 deaths reported of severe pulmonary disease associated with the use of vaping products. All cases in California have required hospitalization; most required supplemental oxygen. Symptoms typically develop over days to weeks, however, 30% of people hospitalized

developed respiratory failure requiring mechanical ventilation. Most patients reported using vaping products that contained cannabis, although nicotine products have been reported as well.

- **Influenza:** We have entered flu season, and last week the Health Officer sent out a masking order that pertains to healthcare workers who decline vaccination or are unable to provide proof of flu vaccination will be required to wear a surgical mask while working in patient care areas from November 1, 2019 to March 31, 2020.
- **County Immunization Clinics:** The number of patients attending the clinics have been low over a long period of time; so, the data was presented to Supervisor Saylor and agency leadership, and consensus was reached that the county will no longer be providing routine immunizations as of October 1st; but will honor the appointments that have already been scheduled. The county will still provide any technical support to anyone who needs it, or if we need to help with linking people who need immunizations to resources in the county that can provide them. The clinic closures will not affect our seasonal flu clinics.
