 - i. The Yolo County First Responders Mental Health Urgent Care Clinic is now open at 500 Jefferson Blvd #B from 12:00pm-9:00pm, 7 days a week. The clinic will see walk in clients, local law enforcement referrals, and PD drop-offs as walk in appointments. Sutter Health will be providing the Nurse Practitioners during this time.
