Situation Update:

Recommendations and guidelines are subject to change as additional information becomes available.

Actions Requested of Healthcare Systems and Clinicians:

1. **MASK** all patients with respiratory symptoms immediately upon arrival at your facility.
2. **IDENTIFY** individuals with potential travel or exposure histories.
 - Immediately implement Travel History Screening on ALL patients
 - If available telephone and video triage is preferred.

Travel History Triage

- History of travel to China:
 - City and Province of Travel
 - China Departure Date
 - United States Arrival Date
 - Were they screened at a US airport?
- Did have close contact with someone diagnosed with **novel** coronavirus?
- Symptoms:
 - Fever?
 - Respiratory? (Cough, Shortness of Breath)
- Where is the patient currently?
 - City of Residence
 - Home/Hospital/At the Clinic
