#### **Health Education**

 Tobacco Prevention Staff presented at the January Health Council Meeting on a smokefree multi-unit housing policy for the Yolo County's unincorporated areas. With the support of the Health Council members, staff will present the policy proposal once again at a Board of Supervisors meeting in the next few months.

In Davis, staff and UC Davis student volunteers completed data collection gauging perceptions and attitudes of a city-wide smoke-free multi-unit housing policy. Results indicate strong support for a comprehensive policy from Davis residents who live in multi-unit housing. In the coming months, staff and students will distribute educational packets to Davis City Council members and request education meetings.

Tobacco Prevention and Flavored Tobacco Ban – On January 15, 2020, the West Sacramento City Council unanimously voted to ban the sale of flavored tobacco products. West Sacramento becomes the third Yolo County jurisdiction to adopt this type of ordinance, behind the Board of Supervisors and Woodland. In addition, City Council signed an agreement with Yolo County to conduct administrative and enforcement activities. The ban will go into effect on April 15, 2020

- Child Passenger Safety Program Child Passenger 2019 Highlights:
  - The Child Passenger Safety Program inspected a total of 467 seats from January to December of 2019.
  - Staff conducted 8 Checkup events in various locations in Yolo County
  - A total of 262 seats were distributed to Yolo County families.
  - o A total of 461 seats were recycled, of which 175 were expired.
  - 12 Child Passenger Education classes were provided to reach low-income residents reaching 85 individuals

- Public Health Accreditation Board (PHAB) Annual Report The PHAB Annual report has been submitted for the 2018-2019 reporting year. This report provides PHAB an overview of the Community Health Branch and Health and Human Services Agency efforts to ensure continued conformity to the standards and measures under which accreditation was originally awarded provides PHAB with highlights of the activities related to quality improvement, continuing processes, and emerging public health issues and interventions conducted in the reporting year.
