

Universal Waste Regulations

Universal Wastes (UW) are common products that, when disposed of improperly, pose risks to human health and the environment. State law requires UW to be taken to a facility that will recycle or properly dispose of them. See the reverse side of this brochure for a location near you.

It is illegal to dispose of universal wastes in the garbage. By doing so, you risk injury to not only your garbage handler but, in the long run, to everyone. Eventually, chemicals in illegally disposed materials end up at the landfill where toxic metals and corrosive substances can be released into the environment and contaminate our air, water and possibly the food we eat.

Yolo County's Household Hazardous Waste Program collects these universal wastes at its drop off collection days. For detailed information log onto www.yolocounty.org and click on the landfill tab or call (530) 666-8729.

For convenience, many retailers, libraries and government buildings collect household batteries free of charge. The next time you visit one of these locations, be sure to ask if they have a collection/recycling program available for their customers.

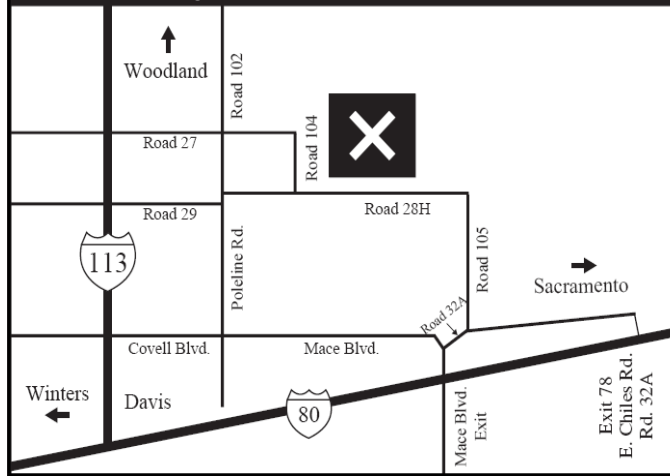

Universal Waste



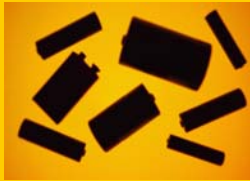
It is **ILLEGAL** to throw universal waste in the trash.



UW Items Include:

Batteries

All household batteries including alkaline, button cell, cell phone batteries, gel cell, lithium, rechargeable batteries and nickel cadmium (Ni-Cd) batteries.



Light Bulbs

Compact fluorescents (CFL's), fluorescent tubes, high intensity discharge, metal halide, sodium and neon. (Incandescent & halogen light bulbs are not included under UW regulations.)



Mercury Containing Devices

Including thermometers, gauges, switches, thermostats, "light-up" shoes, singing greeting cards and flashing jewelry.



Electronic Waste

Including cell phones, computers and peripheral equipment, pagers, radios, VCRs, DVDs, answering machines and TVs.



Microwaves

Microwaves also fall under the universal waste regulations and under the electronic waste category but often will be mistaken as an appliance and be thrown in the trash.



UW Items Include:

Non-Empty Aerosol Cans that Contain Hazardous Materials

Many aerosol cans contain flammables, like butane, as propellants for products like paint. If your aerosol can is labeled with words like TOXIC or FLAMMABLE they most likely fall under the universal waste category and should not be placed in the trash.

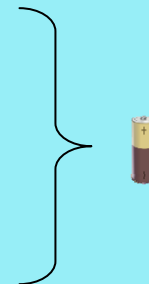
Indicates locations accepting bulb drop off for free.

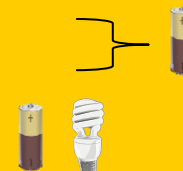

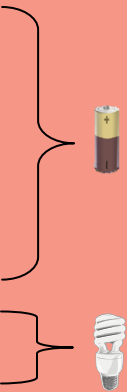

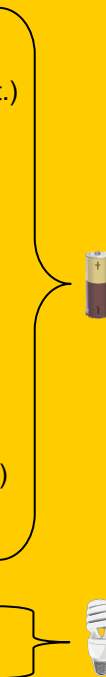
