NOTICE IS HEREBY GIVEN that the Yolo County LAFCO has set Monday, February 25, 2008, at 9:00 a.m. as the date and time to hold a Public Hearing on the Madison Community Services District Municipal Service Review and Sphere of Influence Study in the Yolo County Board of Supervisors Chambers, 625 Court Street, Room 206, Woodland, California.

The hearing will be to receive testimony and consider action on the final Municipal Service Review (MSR) and Sphere of Influence (SOI) for the Madison Community Services District. The MSR is a document used to establish the service information for the review, analysis and recommendations of the community services district. The SOI is a guidance document used by the Yolo LAFCO to help project the direction, type and timing of boundary changes for the district. The Commission will also consider adoption of a Mitigated Negative Declaration as allowed by the California Environmental Quality Act (CEQA). The Madison Community Services District is located in central Yolo County.

The final MSR/SOI and Mitigated Negative Declaration documents will be available for review at the LAFCO office, 625 Court Street, Suite 107, Woodland, California, five days prior to the hearing date. The Agenda will be posted at least five days prior to the noticed hearing at 625 Court Street, and on line at www.yolocounty.org/lafco/Meeting.htm. All interested parties are invited to attend the public hearing.
