10:00 A.M. CALL TO ORDER

The April 9, 2020 Health Council meeting was called to order at 10:03 a.m. by Evan Priestley, Health Council Chair.

1. ROLL CALL – Cyndi Sechler, *Health Council Secretary*

Roll call for voting members was taken and quorum was confirmed.

2. REPRESENTATIVE REPORT OUT – Evan Priestley, *Health Council Chair*

Evan asked Dr. Ron Chapman for an update; and asked the Council members that did not get to share at the last meeting their overview, a best practice, and one challenge they or their entity are experiencing.

- **Ron Chapman, Health Officer** – As of today a total of 67 cases and 3 deaths have been reported. You can visit the Dashboard at www.yolocounty.org/coronavirus and then click on Dashboard tab.

Dr. Chapman spoke at the Board of Supervisor’s meeting, Davis City Council, and is scheduled to speak next week at the Woodland City Council meeting. Everyone is interested in getting the information out to the communities. A lot of information and education has been going out on several different topics which can be found on the County’s website. One hot topic is face coverings, and the difference between face coverings, N95 and surgical masks. The Centers for Disease Control put out recommendations to wear face coverings to prevent the spread to asymptomatic individuals.

We also continue to be extremely busy with isolation and quarantine identification of cases and we are working with partners throughout Yolo County.

- Members shared their overviews, a best practice and one challenge they or their entity are experiencing.

3. ESTABLISH HOME COMMITTEE(S) – Evan Priestley, *Health Council Chair*

At the April 2nd Health Council meeting, some members of the Council expressed interest to have actional next step in developing an ad hoc committee to help in an areas of need. One area of need discussed was to organize cloth masks and the donations for production, and to provide masks to asymptomatic people.

Evan called for a motion to create a committee and explore the coordination of cloth masks.

Pat Moore Pickett volunteered to be the point of contact for the committee and to report the findings to the Health Council.

Evan mentioned another idea for an ad hoc committee is how to harness the resources of the Health Council’s district representatives to amplify voice or messaging and engage a community response. Evan asked if the district representatives are willing to commit to an ad hoc committee and other board members to work on that as well.

Supervisor Saylor advocated for amplifying the existing messaging to go through the county representatives.
