Agenda Item No. 5.03 Executive Director Comments

Received comments from the Executive Director. Ms. Baker addressed the Board of Commissioners and provided an update on the following issues:

- They have a new electronic ID system and adopted a color striping system for Emergency Services (OES) workers so they could report for duty. Next week they have their quarterly meeting and will receive their photo ID's.
- Madison, Winters, Davis Migrant Centers formed a soccer league with the grant from the Sierra Health Foundation, which is up and running and so far seems to be a successful

- program. Folks from UC Davis will be offering a soccer clinic for residents to work on their skills and abilities.
- There is a non-profit organization called 'Computers for Kids' out of West Sacramento, which refurbishes Microsoft Computers and sells them at a cost of \$100 each. YCH is looking at purchasing 23 computers to refurbish all of their computers in their computer labs. YCH also agreed to place a link on their website to this organization because these computers are available for \$100 to low income youth. Very excited about this program, as it will provide computer access to low-income residents.
- Finalizing agreement with Fair Plaza East for project based vouchers and will be able to take 27 vouchers, which will be a way to support leasing caseload, provide housing that might not otherwise be out there and will also allow new property owners to be able to use that actual anticipated income in obtaining financing to make needed physical improvements to that property. Collaboration between the City of Woodland, Yolo County Housing and new owners at Fair Plaza East.
- Contract to start the full analysis on their carbon foot printing.
- In the Family Self Sufficiency Program, three to six people have met their goals and they hope to hold graduations for them in September.
