

## **COUNTY ROAD 32A RAILROAD CROSSING RELOCATION PROJECT STUDY**

The County retained TY Lin International (TYLI), a civil engineering consulting company to prepare a Project Study Report (PSR) to establish alternatives and a preferred option for replacing the County Road 32A railroad crossing at County Road 105, with a new crossing within two miles east of the current crossing. At-grade and grade-separated crossings will be considered. Environmental, engineering, safety, cost considerations, and funding opportunities will be reviewed.

### **DRAFT ALTERNATIVES (Click the links below to view each alternative)**

TYLI has prepared the following three draft alternatives for consideration as a proposed option for relocating and improving this crossing:

Alternative 1: Overhead Layout, 50 MPH Design Speed (Bridge Crossing)

Alternative 2: At-Grade Crossing, 40 MPH Design Speed

Alternative 3: At-Grade Crossing, 45 MPH Design Speed

The following four draft alternatives were reviewed, but have been removed from further consideration, mainly due to higher project and right-of-way acquisition costs, drainage challenges, and ongoing facility maintenance concerns:

Alternative 4: Underpass Layout, 55 MPH Design Speed (Tunnel Crossing)

Alternative 5: Overhead Layout, 55 MPH Design Speed (Bridge Crossing)

Alternative 6: Overhead Crossing, 55 MPH Design Speed (Bridge Crossing)

Alternative 7: Undercrossing Crossing, 55 MPH Design Speed (Tunnel Crossing at I-80 ramp intersection)
