Change to Assessor's Office Public Counter Hours Beginning Monday, August 3rd

Woodland, CA – Due to the COVID-19 pandemic, beginning Monday, August 3rd, the Assessor's Office public counter hours will be changed to Monday through Friday, 8:00 a.m. to 4:00 p.m.

We continue to make every effort to balance public service while creating a safe environment for both staff and residents during the pandemic. The Assessor's staff availability via phone or email remains unchanged. Earlier this month the Assessor's Office closed the assessment roll ahead of the statutory deadline of July 1, 2020, despite the unprecedented times of the COVID-19 pandemic.
