9:00 A.M. CALL TO ORDER

The July 23, 2020 Health Council meeting was called to order at 9:04 a.m. by Evan Priestley, Health Council Chair.

1. WELCOME – Evan Priestley, Health Council Chair

2. ROLL CALL – *Cyndi Sechler, Health Council Secretary*Roll call for voting members was taken and quorum was confirmed.

- 5. STATE AND COUNTY UPDATE Jill Cook, County Administrator's Office
 - County Budget: Since our last recommended budget in early June, the county has had several positive
 developments including increased property tax due to the assessment growth, and increase
 Proposition 172 factor for Public Safety Sales Tax, partial realignment backfill, and the receipt of CARES
 money to respond to the COVID-19 pandemic through the end of this calendar year. We believe we
 could close the adopted budget gap through some targeted reduction.
- 6. BOARD OF SUPERVISORS UPDATE Supervisor Don Saylor, District 2
 - Resolution: At the July 21st Board meeting, the Board of Supervisors voted to approve Resolution No. 20-76 recognizing racism as a public health crisis. This is a topic that has been addressed by both the Health Council and the Local Mental Health Board. Supervisor Saylor suggested that the Health Council and the Local Mental Health Board receive the Resolution and would like Council to consider a discussion about ways to advance the purposes that are identified and addressed in the resolution.

There have been some ongoing discussions about the potential adoption of a second related resolution regarding the same issue and its impacts through the criminal justice system in Yolo County.

7. HEALTH OFFICER REPORT – Mary Ann Limbos, Interim Health Officer

- **Dashboard:** We are making changes on how we report cases on the Dashboard. The number of cases will be closer to what the state is reporting. As of July 22nd, Yolo County has 1,225 lab confirmed cases of COVID-19 which was an increase of 26 cases from the previous day.
- **Testing:** We are testing more residents, so our testing numbers are going up, and of those tests the percentage of positive cases are at 6-7 percent, and the positive test rate for the state is at 9 percent.

We now have a webpage that is devoted to Yolo County COVID-19 testing, and it provides categories for testing options for residents with and without insurance. The webpage will be updated monthly.

Test results from several of the commercial labs are significantly delayed in terms of 10-14 days of us receiving them. We are working toward a strategy for people to proactively isolate and quarantine once they have taken the test and waiting for their results. We are rolling out an Isolation and Quarantine Education Tool Kit that will be available on our website and we hope to distribute this at our testing sites as well as to local providers.

- Contact tracing: We are prioritizing our contact tracing because of the delay in testing results. We
 realize our energies should not be devoted in trying to contact every positive case; but rather those
 cases that are in high risk populations such as the long term care facilities, skilled nursing facilities,
 schools and child care, our industries and businesses that are showing clusters of employees with
 positive tests.
- **Schools reopening:** On July 17th, the state announced the criteria for schools reopening, and announced that schools will only be able to open for in-person instruction if they are located in a county that has been off the state's county monitoring list for 14 days. All other school districts that are in a county that is on the monitoring list will have to open with distance learning.

Evan suggested moving forward that we look at our meeting structure so that we have dedicated time to continue being the community sounding board for the COVID response, and also have opportunity to drive the bigger picture strategy in health equity work that we are striving for.

Evan proposed that the Council meets twice a month with the first meeting held on the second Thursday of each month for 2-hours. This would give the Council opportunity to get back to the strategic focus, health equity work, looking upstream, start to influence some of the larger systems that create different health outcomes, and hopefully reduce health disparities over time. The next meeting could be held on the fourth Thursday of each month for 1-hour with the meeting being more COVID response specific.

11. PUBLIC COMMENT

John Troidl, Public – Dr. Brad Pollock appeared at a UC Center presentation along with Health Officer from Placer County, and a faculty member from UCSF recently, and he had great slides, and he had interesting things to say about preparations at UC Davis and systemwide. He would be a great speaker for the Health Council.

John is involved with students that are looking at different dashboards across the capitol region and bay area. In Santa Clara County, they have added to their dashboard reports on testing by provider. It is a good way of giving the health systems credit for work that they are doing contributing to the public health effort and recommends that Yolo County considers adding that feature to the dashboard.
