


- Will include near and long-term actions



Step 1: What is Yolo County doing about sustainability now?

- Existing conditions set a "baseline" for the plan.
- Plans for the future by understanding the past.
- Considers the many existing plans, programs, and actions related to sustainability in the County.
- Includes research on:
 - Agencies and groups that supported development and implementation of existing plans.
 - Progress made on existing objectives.

Element 1: Ecological Health

Promote and sustain the benefits provided by a healthy ecosystem

Element 2: Water

Ensure an abundant, safe, and sustainable water supply to support the needs of existing and future generations

Improve air quality in the County, with a focus on low-income communities that bear a disproportionate pollution burden

Promote locally grown products and connect farmers to County residents through school programs, tourism, and farm-to-table restaurants


Increase outreach, awareness, and education in sustainability topics
