



## STATE OF CALIFORNIA MANDATES - BUSINESSES

### AB1826 - ORGANICS RECYCLING

California law requires businesses that generate 2 cubic yards or more of solid waste per week to recycle the organic portion of their waste. Organics include food scraps, food-soiled paper, landscape trimmings and nonhazardous wood waste. See panel on reverse side for more Multi-Family information.



### AB341 - RECYCLING

The commercial sector generates nearly three fourths of the solid waste in California. Much of the commercial sector waste disposed in landfills is recyclable. AB 341 requires all businesses that generate 4 cubic yards or more of solid waste per week to arrange for recycling services. See panel on reverse side for more Multi-Family information.



### SB 1383

SB 1383 establishes targets to achieve a 50 percent reduction in the level of the statewide disposal of organic waste from the 2014 level by 2020 and a 75 percent reduction by 2025. The law grants CalRecycle the regulatory authority required to achieve the organic waste disposal reduction targets and establishes an additional target that not less than 20 percent of currently disposed edible food is recovered for human consumption by 2025. SB 1383 will further support California's efforts to achieve the statewide 75 percent recycling goal by 2020 established in AB 341 and strengthen the implementation of mandatory commercial organics recycling established in AB 1826.

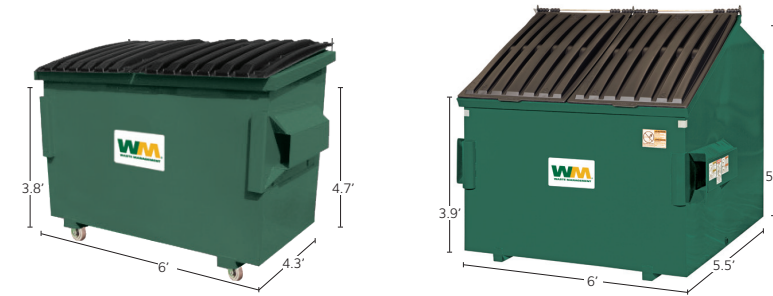

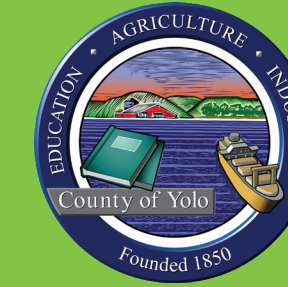

### RECYCLE RIGHT

When you place the right materials in the right container, and do not overfill them, it benefits you and your community and protects the environment. Be sure to follow the guide on the reverse side to recycle right, and avoid contamination and overage charges.

**Contamination Charges:** After receiving 3 warning notices on your recycling cart within 12 months, an additional charge will occur to the customer.

**Overage Charges:** After receiving 3 warning notices, customer's cart will be upsized automatically. Customers may not request a reduction in service for a period of twelve (12) months.

*(Please place palm fronds, yucca and cacti in the Trash)*



Food Scraps, Including Egg Shells,  
Meat & Bones



Pizza Boxes & Food-Soiled Paper, Napkins,  
Paper Towels, Coffee Grounds, Tea Bags



## STATE OF CALIFORNIA MANDATES - MULTIFAMILY COMPLEXES



### AB1826 - ORGANICS RECYCLING

California law requires businesses that generate 2 cubic yards or more of solid waste per week to recycle the organic portion of their waste. Multifamily complexes with 5 or more units are required to recycle only landscape waste.



### AB341 - RECYCLING

The commercial sector generates nearly three fourths of the solid waste in California. Much of the commercial sector waste disposed in landfills is recyclable. AB 341 requires all businesses that generate 4 cubic yards or more of solid waste per week to arrange for recycling services. Multifamily complexes with five or more units are also required to have a recycling program.



### RESOURCES
