### **Shared Vision Statement**

Yolo County Animal Services is a statewide leader in animal services whose coordinated approach ensures compassionate treatment of animals, effectively educates the public regarding animal services, ensures the safety of all animals and people, and reduces long term costs through implementing best practices to reduce animal intake.

### **Mission Statement**

*The mission identifies the goals of our operations, what services we provide, and who we provide them to.*

Yolo County Animal Services safeguards its people and animals through a combination of education, prevention methods, operational excellence, and a commitment to reducing the number of homeless animals entering shelters, increasing pet adoptions, and reducing euthanasia of healthy or treatable animals.

## Example Objective, Strategy, Tactics

<b>Goal 1</b>	<b>Public Health &amp; Safety</b>
<b>Objective</b>	Reduce public health risks associated with zoonotic and animal borne disease through effective public health programs.  <i>Metrics: # of disease transmissions by animals by location and over time, # of human-animal interactions involving injuries</i>
<b>Strategy</b>	Implement proactive policing models for animal services congruent with Problem-Oriented Policing and Community-Oriented Policing by December 2023.
<b>Tactics</b>	<ul style="list-style-type: none"> <li>Analyze calls for service, determining frequency and type of calls</li> <li>Identify “hot spots” or areas with high concentration of animal-related calls</li> </ul>
<b>Goal 2</b>	<b>Education &amp; Outreach</b>
<b>Objective</b>	Increase public education and outreach and develop a volunteer program to assist achieving organizational goals.  <i>Metrics: # of individuals engaged in volunteer efforts, # of individuals/households reached out to via social media or other engagement efforts</i>
<b>Strategy</b>	Develop a formal humane education program consisting of regular classroom visits, volunteer and teacher training, and adult education opportunities, and spay/neuter awareness campaign by December 2023.
<b>Tactics</b>	<ul style="list-style-type: none"> <li>Develop cost analysis for staffing outreach/education and volunteer programs</li> <li>Hire an Outreach/Education Director to develop education programs</li> <li>Hire a Volunteer Coordinator to develop a volunteer program</li> <li>Develop a framework for public education and outreach efforts, including budgetary requirements, engagement parameters, and intended outcomes</li> </ul>
<b>Goal 3</b>	<b>Operational Excellence</b>
<b>Objective</b>	Reduce economic impact of animal shelter operations on Yolo County.  <i>Metric: Animal Services revenue generation against cost to operate programs</i>
<b>Strategy</b>	Create a licensing unit that pursues proactive licensing compliance and generates revenue by December 2024.
<b>Tactics</b>	<ul style="list-style-type: none"> <li>Develop cost analysis for the implementation of a licensing unit</li> <li>Hire licensing unit staff and begin implementation</li> </ul>
<b>Goal 4</b>	<b>Humane Treatment of Animals</b>
<b>Objective</b>	Reduce the number of homeless pets in Yolo County.  <i>Metric: Comparison of # of homeless pets by location and over time, # of pets housed per year, # of licensed animals in Yolo County</i>
<b>Strategy</b>	Establish a spay/neuter program including a high-volume, low cost spay/neuter clinic by December 2025.
<b>Tactics</b>	<ul style="list-style-type: none"> <li>Develop cost analysis for the implementation of a spay/neuter clinic</li> <li>Identify location and schedule for the licensing unit and spay/neuter clinic</li> </ul>
