General Plan Update Workshops and Presentations

(Woodland, CA) – In May 2003, the Yolo County Board of Supervisors gave direction to begin an update of the current General Plan. This is only the third time in the county's history that the General Plan has been comprehensively updated. The General Plan is the basic document used by local government in land use planning. It provides the comprehensive long-term plan for the physical development of the county, and is often referred to as "the constitution" of the county. All cities and counties are required, under state law, to have one.

On September 10, the Draft General Plan was released for public comment and is now available online at www.yolocountygeneralplan.org. Hard copies are available for viewing and check-out at all Yolo County library branches (visit: www.yolocountylibrary.org for branch locations) and the Yolo County Planning & Public Works (PPW) Department (292 West Beamer Street in Woodland). Hard copies are also available for purchase at PPW for \$50.00 or on CD for \$4.50.
