## WATER OPERATION



### WATERING SCHEDULE

The lawn watering schedule for September & October is a maximum of 3 days/week with a maximum time of 12 minutes/station. These requirements do not pertain to drip irrigation. Your water system should be turned off in November and December.



For maximized water absorption, and to reduce water run off—Water for only 6 minutes twice each watering day

### POOL DRAINING TIPS

When it is time to drain your pool, please drain the water to the drainage system (where your roof gutters go) or to the gutter in front of your home. **PLEASE DO NOT DRAIN TO THE SEWAGE SYSTEM.** Pools drained to the sewer end up at our wastewater treatment plant. Excess water at the plant can lead to exceeding the capacity of the plant, which can result in non-compliance with the State Requirements. The State may then choose to fine the community, which could result in an increase in our sewage rates.

### ARSENIC TREATMENT

Luhdorff & Scalmanini Consulting Engineers (LSCE) have now completed Phase 2 (Conceptual Treatment & Operational Strategies) for the Wildwings arsenic treatment project.

Phase 2 looked at the following five options for arsenic treatment. 1) Construction of a new well, 2) Blending both wells without treatment, 3) Coagulation/Filtration to remove arsenic, 4) Adsorption system to remove arsenic, and 5) Combination of treatment and blending. LSCE has currently removed Options 1, and 2 from further consideration due to costs for Option 1, and due to not consistently meeting State requirements for Option 2. Phase 3 will proceed and consists of obtaining proposals for pilot testing of Options 3 and 4 (Coagulation/Filtration & Adsorption) and they will determine sizing requirements and costs for the remaining options.

However, during the latter part of August play temporarily decreased due to temperatures over 100 degrees and smoky conditions from the recent fires.

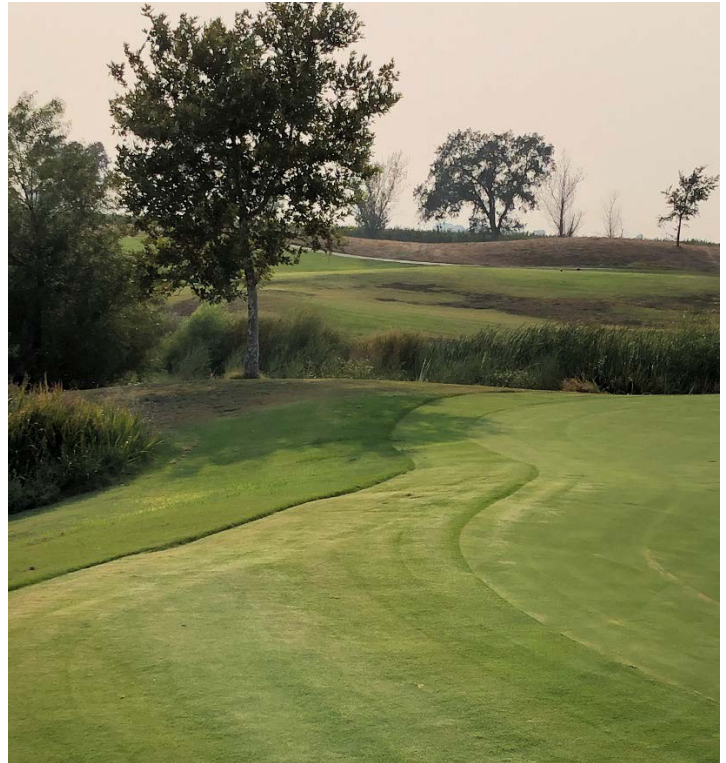
# FOOD TRUCKS

## **GOLF COURSE PONDS**

The County management team has met with the Yolo County Flood Control and reviewed the upcoming work that will be done to the ponds and surrounding areas this fall. All the ponds will have the entrances and exits cleaned of debris and cattails so that stormwater can more easily flow through. In addition, special emphasis will be placed on the ponds that are located near Holes 6 and 7 to remove dead wood, trim up the willow trees, and improve the view for the adjacent home owners.

## **WASTEWATER**

The wastewater treatment plant continues to run well. Work is scheduled to begin in September on installing a taller antenna at the wastewater treatment plant. The current antenna was installed when the development was first built and trees throughout the community have now grown tall enough that their leaves and branches are obstructing the radio signals, thus hampering communications between the lift stations, ponds, and both water wells.
