Organic Waste/Composting/Anaerobic Digestion Update:

In-Vessel Digester project update:

<u>Food depackager</u>- Depackager testing was successfully completed in October 2020 and final report submitted to Regional Water Quality Control Board (RWQCB) for approval before starting the operation.

<u>Electrical Control Panel for In-Vessel Digester Project</u>- Project was awarded to Butterfield Electric, Inc, on January 12, 2021 by Board of Supervisors (BOS). Work to start soon after.

Anaerobic Composter Operation (Composting Facility #1)

UCD staff COVID-19 infection delayed the preparation of final report which was due on December 23, 2020 to January 2021. Report was submitted to YSAQMD on January 25th. Results showed overall significant lower emissions that estimated in the application.

<u>Organics Agreements with Cities</u> – County emailed agreement to all cities in November 2020 and waiting to hear back from cities.

<u>Organics Agreement with County of Sacramento</u> – Final agreement will be approved by County of Sacramento in February 2021.

<u>Future C&D Recycling and Composting Facility#2 (Northern Recycling)</u>- Design of the C&D Recycling and Composting Facility #2 is under way. Construction will start in Spring 2021 and is projected to be completed and ready for operation by July 2022.

Landfill Module Closure:

Closure of Waste Management Units 4 & 5-Project was accepted by BOS as complete.

Landfill Environmental Impact Report (EIR): County staff continue to work with consultant on the landfill EIR.
