Subject: Support for Signing Assembly Bill (AB) 332 regarding Treated Wood Waste Management

Secretary Blumenfeld,

On September 29, 2020 Governor Newsom vetoed SB 68 (Galgiani), which would have repealed the sunset date for management and disposal of Treated Wood Waste (TWW) in a composite-lined portion of a solid waste landfill - standards that have been in place since 2004. The solid waste industry and local governments are largely responsible for managing the handling and disposal of TWW. Now that the Health and Safety Code Section 25150.7 expired on December 31, 2020, we face significant management challenges and **an exponentially increased risk of illegal TWW disposal**. We are concerned that the veto of SB 68 leaves us with no effective management standards or guidance for TWW, no practical alternatives for managing the handling and disposal of this waste.

As of January 1, 2021, "... all hazardous treated wood waste managed in California must be stored and manifested as hazardous waste and transported to class I hazardous waste landfills for disposal." As a result, any treated wood that is generated by a business or household is subject to the full range of standards for management and disposal of hazardous waste. These include a limit that the material cannot remain on the generator's site longer than 90 days, cumbersome storage and labeling requirements, required shipment on a hazardous waste manifest, and disposal at a full hazardous waste facility.

Yolo County currently accepts an average of **350,000 pounds annually at our Central Landfill's Construction and Demolition Facility.** This material comes from a variety of sources and is transferred offsite for proper disposal at the Kieffer Landfill in Sacramento or the Hay Road Landfill in Vacaville, both of which are no longer options if action is not taken to reverse course on the Veto of SB68.

If Assembly Bill 332 is not signed, and TWW is required to be disposed in a hazardous waste Class I landfill, it will create significant disruptions to local waste handling operations and significantly increase illegal disposal. Transportation costs are also prohibitive, given that there are no more than three Class I landfills in California, and all are located in remote areas that are considerable distances from where TWW is generated. For perspective, **a typical household currently pays \$35** to get rid of a mini-pickup truck worth of TWW fencing from their yard. The Veto of SB 68 has created an unrealistic cost of approximately **\$420 for that same load.**

These types of cost increases greatly increase the potential for illegal dumping and burning by both residents and businesses, as traditional transportation and disposal pathways may turn away those wastes or customers may be unable or unwilling to pay for this. Any increase in illegal disposal will result in additional cost pressures on already strained state and local governments that will have to clean up those illegal hazardous waste disposal sites.

A recent study required by SB 162 (Galgiani, Chapter 351, Statutes of 2015), TWW Implementation of Senate Bill 162, found a 93% compliance rate with the Alternative Management Standards (AMS), ensuring the protection of the environment and public health. Furthermore, the AMS decreased illegal dumping of TWW to "no reported instances." Administrative type violations were noted in the review and were primarily addressed in SB 68 with improved data collection, outreach, and reporting.

The existing alternative management standards effectively result in proper management of TWW and a curtailment of illegal dumping, illegal burning, and illegal storage. Local governments are particularly concerned with illegal management of TWW now that the standards have expired. Without the old management standards, illegal dumping and burning will increase dramatically as homeowners, farmers, wineries, and businesses come to realize the increased costs and complex procedures that are now in place through the variance program offered by DTSC.

To avoid these outcomes, we strongly recommend that Cal EPA, DTSC, and the Governor's Office work expediently toward signing Assembly Bill 332, to require the treated wood waste regulation that was adopted before January 1, 2008, pursuant to previous provisions exempting a hazardous waste management activity from one or more of the requirements of the hazardous waste control laws to remain valid unless repealed. AB 332 should repeal this provision as of an unspecified date and declare that it is to take effect immediately as an urgency statute.

Thank you for your attention to this matter of statewide and local concern.
