# AGREEMENT NO. 2200 (Amendment # 5 to Short-form Agreement No. 5959-2017-PUMPSTATION)

THIS FIFTH AMENDMENT TO AGREEMENT 5959-2017-PUMPSTATION is made this 13Thday of Mach, 2019 by and between the County of Yolo ("COUNTY") and Luhdorff & Scalmanini Consulting Engineers, ("CONTRACTOR"), who agree as follows:

#### AMENDED TERMS

- 1. CONTRACTOR shall perform the following ADDITIONAL personal services: Additional services as set forth in Exhibit B-3 with regard to the Wild Wings CSA water system.
- 2. CONTRACTOR shall perform these personal services between March 13, 2017 and June 30,2020.
- 3. Subject to CONTRACTOR's satisfactory fulfillment of the terms and conditions of this Agreement, and upon CONTRACTOR's submission of an appropriate claim or invoice, COUNTY shall pay CONTRACTOR a total amount of up to \$46,000.

#### ADDITIONAL TERMS AND CONDITIONS

- 4. Extend contract end date to June 30, 2020. Raise total compensation by \$9,500 for a total amount of up to \$46,000. Add Exhibit B-3 to scope of work. Billable rates for the services performed beginning January 1, 2019 may be charged up to the 2019 rate schedule included with exhibit B-3, provided that total aggregate amount paid to contractor does not exceed the maximum compensation described above.
- 5. Perform services as set forth in Exhibits B, B-1, B-2, and B-3. Except as set forth in this Fifth Amendment, the terms of the original contract shall remain unchanged.

### Exhibit B-3 Exhibit A: Scope of Services

Contractor shall perform the following technical assistance tasks to in providing technical assistance related to corrective action to various components of the Pintail and Canvas Back wells and distribution system at the Wild Wings County Service Area:

Assist the County with the procurement of the materials and labor to extend the pump setting depth of both well pumps. This work involved the development of an abbreviated technical specification, contacting various contractors, answering bid questions, receiving and evaluating bids and providing the County with recommendations for award. The total amount billed to County for this task shall not exceed \$3,400.

Develop a proposed operating scenario to provide the system with water while the well pumps are out of service. Obtain operating approval to use the standby Canvas Back Well from the Division of Drinking Water (DDW) and prepare any standby use reports to DDW. Meet with the system operators and the contractor to review the proposed operating scenario.

Inspect the pump extension installation and materials and document such for DDW review and approval.

Perform well pump testing upon completion of the work and update the County maintenance records for the well pumps.

Assist the operators in operating both pump stations and associated valving to ensure the proper operation, settings, and functioning of the water system.
